ORDINANCE 490

AN ORDINANCE AMENDING CHAPTER 2, OF THE CODE OF THE CITY OF CHARLOTTE BY ESTABLISHING A NEW ARTICLE, ARTICLE IV, ENTITLED MOTOR TRANSPORT AND SANITATION DEPARTMENTS.

BE IT ORDAINED by the City Council of the City of Charlotte, North

Carolina:

Section 1. Motor Transport Department created.

There is hereby created a Motor Transport Department whose primary objectives shall be to insure the most effective use of all city equipment, to achieve optimal unit operating costs, and to clearly define the equipment needs of the City. The Motor Transport superintendent shall be appointed by the City Manager and shall perform the duties of his office until removed therefrom,

Section 2. Sanitation Department created.

There is hereby created a Sanitation Department whose primary objectives shall be to collect and dispose of garbage, refuse, and trash, clean all permanently paved streets in the City, and perform such other duties as may be required to provide the citizens of Charlotte with sanitary living conditions.

The Sanitation Department superintendent shall be appointed by the City

Manager and shall perform the duties of his office until removed therefrom.

Section 3. This ordinance shall become effective January 26, 1970.

Section 4. All ordinances or parts of ordinances in conflict herewith

are hereby repealed.
