An Ordinance Amending the City Code
with respect to the Zoning Ordinance

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That, Chapter 23, Section 23-8, of the Code of the City of Charlotte is hereby amended by changing from R-1.0 MF to B-3 on the Official Zoning Map, City of Charlotte, N. C. and Perimeter Area the following described property:

BEGINNING at the southerly corner of the intersection of North Poplar Street and West 7th Street and running thence with the southwesterly margin of West 7th Street S. 41-36-00 E. 175.47 feet; thence S. 51-17-00 W. 91.10 feet; thence S. 41-36-00 E. 2.88 feet; thence S. 47-58 W. 99.0 feet thence to the centerline of an alley; thence with said centerline N. 41-34-30 W. 184 feet more or less to the southeasterly margin of North Poplar Street; thence with said southeasterly margin of North Poplar Street N. 51-12-20 E. 190 feet, more or less, to point of BEGINNING.

Section 2. That, this ordinance shall become effective upon its adoption.


WHEREAS, the owner (s) or those person (s) responsible for the maintenance of these premises have failed to comply with the said order served by registered mail on April 30, 1970: and
