An Ordinance Amending the City Code  
with respect to the Zoning Ordinance


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That, Chapter 23, Section 23-8, of the Code of the City of Charlotte is hereby amended by changing from R-9 to R-6MF on the Official Zoning Map, City of Charlotte, N. C. the following described property:

BEGINNING at a point on the easterly margin of Flynnwood Drive, said point being located at the southwesterly corner of lot 5 in block 2 of Flynnwood subdivision as shown on a plat recorded in Map Book 6, page 929 in the County Public Registry, and running thence S. 75-09 E. 213.50 feet; thence N. 14-47-36 E. 160.04 feet; thence S. 74-30-09 E. 10-20 feet; thence N. 10-58-27 E. 5.86 feet; thence S. 77-35-31 E. 185.33 feet to the westerly margin of Merry Oaks Road, and running thence with said margin S. 12-29 W. 255 feet, more or less, to an existing R-6MF zoning district boundary line, and running thence with said line in a northwesterly direction 420 feet, more or less, to the easterly margin of Flynnwood Drive, and running thence with said margin N. 14-41 E. 80 feet, more or less, to the point of BEGINNING.

Section 2. That, this ordinance shall become effective upon its adoption.

ORDINANCE NO. 448-X

AN ORDINANCE AUTHORIZING THE TRANSFER OF FUNDS FOR THE  
CONSTRUCTION OF PHASE III OF THE McMULLEN OUTFALL.
