 - (1) Gross income from ticket sales and space rentals up to \$10,000.00....\$\$100.00
 (2) Each additional \$1,000.00 in excess of \$10,000.00

but not more than \$50,000.00

- (4) Gross income from ticket sales and space rental of \$150,000.00 or more \$500.00
- (b) All exhibitors in any such promotion, exhibition or public show shall be exempt from the payment of license taxes under this chapter, if said license taxes are imposed upon them solely by reason of sale or offer of sale of goods, wares or merchandise at any promotion, exhibition or show from which the tax required by this subsection has been paid."
