- 2. Amend Article II. Zoning Districts, Maps and General Regulations.

 Division 3. General Regulations Section 23-13 by changing paragraph (c) to read as follows:
 - "(c) One-family attached dwelling units need not abut a street provided that all portions of every dwelling unit shall be located within three hundred (300) feet of a public or private street that furnishes direct access to the property and that access to each dwelling unit shall be made available via either a public right-of-way or a private street or vehicular or pedestrian way owned by the individual unit owner in fee or in common ownership."
