AMENDING CHAPTER 11

ORDINANCE 116

AN ORDINANCE AMENDING CHAPTER 11, ENTITLED "LICENSES" OF THE CITY CODE, AND READOPTING IT AS THE REVENUE ORDINANCE OF THE CITY OF CHARLOTTE FOR 1974-75.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina that:

Section 1. Chapter 11 of the City Code of the City of Charlotte is hereby amended in the following manner and readopted and continued in force as the Revenue Ordinance, levying, assessing, imposing and defining the license and privilege taxes of the City of Charlotte for the fiscal year beginning July 1, 1974 and ending June 30, 1975.

Sec. 2. Chapter 11, Section 11-18, Classification (14) "Auctioneers" and (15) "Auctioneers of Jewelry" are deleted in their entirety.

Sec. 3. Section 11-18, Classification (16.1), "Auto and/or Truck Rental and/or Lease" shall be amended by deleting subsections (a) and (b) in their entirety and substituting in lieu thereof the following:

<u>Sec. 4.</u> Classification (53) of Section 11-18, Chapter 11, shall be amended deleting the words "gross income." in the ninth line in subsection (a) under "Building Contractors", and substituting in lieu thereof the words "total annual contract price." It is further amended by deleting all of the classification appearing after subsection (g), and substituting in lieu thereof the following:

"When the total contract price is:	
Up to 100,000 annually	50.00
100,001 to 500,000 annually	75.00
Over 500,001 annually	100.00

If building contractor holds State license, city license is

<u>Sec. 5.</u> Classification (81), "Contractors" of Section 11-18 of the City Code shall be amended by deleting the fee schedule between subsection (a) and subsection (b), and substituting in lieu thereof the following words:

<u>Sec. 6.</u> Classification (93), "Detective-Private", Section 11-18 of the City Code shall be amended by deleting it in its entirety.

<u>Sec. 7</u>. Classification (100), "Dyestuffs and Chemicals", Section 11-18 of the City Code shall be amended by the addition of a new subsection to read as follows:

> "(g) Each 10,000, or a portion thereof, in excess of 1,500,000.00

Maximum license fee shall not exceed 1,000.00."

<u>Sec. 8.</u> Classification (120), "Fish and Oyster Dealers - Retail, Section 11-18 of the City Code shall be amended by deleting the license fee of "7.50" under subsection (a), and substituting in lieu thereof, a fee of "15.00".

<u>Sec. 9</u>. Section 11-18, Chapter 11 of the City Code shall be amended by deleting in its entirety, Classification (138.1), "Guard and/or Patrol Service".

<u>Sec. 10</u>. Classification (157), "Interior Decorators", Section 11-18 of the Code shall be amended by deleting the fee "22.50" and by substituting in lieu thereof the following:

"(a)	gross income to 5,000	15.00
(b)	each additional 1,000 over 5, 000	.60"

Sec. 11. Classification (158), "Itinerants", Section 11-18 of the Code shall be amended by deleting the fee schedule, and substituting in lieu thereof the following new fee schedule:

"(a)	per day	4.50
(b)	per week	15.00
(c)	per month	25.00
(d)	per quarter	50.00"

Sec. 12. Classification (165), "Landscape Contractor", Section 11-18 of the Code is amended by deleting the fee schedule and substituting in lieu thereof the following new fee schedule:

"(a)	not more than 50,000 gross income	50.00
(b)	50,001 to 100,000	75.00
(c)	over 100,001	100.00"

<u>Sec. 13.</u> Classification (183), "Magazines or Periodicals", Section 11-18 of the Code is hereby amended by deleting the license fee for "(a) Published quarterly", "7.50", and substituting in lieu thereof a new fee of "15.00".

<u>Sec. 14</u>. Classification (190), "Meats, Fresh, retail", Section 11-18 of the Code is hereby amended by changing the fee schedule for "(a) annual gross sales; not over \$5,000.00" from "7.50" to "15.00".

Sec. 15. Chapter 11, Section 11-18 of the Code is hereby amended by deleting Classification (259), "Real Estate Auction Sales" in its entirety.

<u>Sec. 16</u>, Classification (292), "Soft Drink", Section 11-18 of the Code is hereby amended by the deletion of the words "Selling in or from bottles" from the classification.
