It shall be unlawful for any person operating a vehicle to make a right turn on a red traffic light at the intersections set forth and contained in Schedule "A" attached to this ordinance and incorporated herein as a part of this section. Schedule "A" shall be compiled and kept as a part of the official records of the City in the Office of the City Clerk.

<u>Sec. II.</u> The prohibition of right turns on red traffic signals contained in this ordinance shall become effective after the erection of signs at the intersections giving notice thereof.
