BE IT FURTHER RESOLVED that \$2,850.00, the amount of the appraised value of said property, is hereby authorized to be deposited in the office of the Clerk of Superior Court in Mecklenburg County, North Carolina, together with the filing of the Complaint and Declaration of Taking.
