AN ORDINANCE TO AMEND ORDINANCE NO. 214-X, THE 1974-75 BUDGET ORDINANCE, AMENDING REVENUES AND EXPENDITURES TO PROVIDE AN APPROPRIATION FOR THE LEAA-FUNDED PIEDMONT CRIMINAL INTELLIGENCE COUNCIL PROJECT.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;


Section 1. That Section 1, Schedule A (General Fund Expenditures) is hereby amended to add an appropriation in the amount of \$9,431 for the operation of the Piedmont Criminal Intelligence Council project.

Section 2. That Section 2, Schedule A (General Fund Revenues) is hereby amended to increase the intergovernmental revenue estimate by \$9,431, representing the amount of the sub-grant award contract between the City of Charlotte and the North Carolina Department of Natural and Economic Resources, Division of Law and Order, for continuation of the Piedmont Criminal Intelligence Council project.

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance shall become effective upon its adoption.

AN ORDINANCE TO AMEND ORDINANCE NO. 214-X, THE 1974-75 BUDGET ORDINANCE, AMENDING REVENUES AND EXPENDITURES TO PROVIDE AN APPROPRIATION FOR THE OPERATION OF THE GOVERNMENTAL PLAZA PARKING FACILITY.

BE IT ORDAINED by the City Council of the City of Charlotte,
North Carolina;

Section 1. That Section 1, Schedule A (General Fund Expenditures), is hereby amended to establish a new appropriation entitled Governmental Plaza Parking Facility - Account No. 530.55 - in the amount of \$12,000. These funds will be used to pay concession management fees and operational expenses for the Governmental Plaza Parking Facility for the remainder of the fiscal year.

Section 2. That Section 2, Schedule A (General Fund Revenues), is hereby amended to increase the General Fund revenue by adding a revenue estimate for the Governmental Plaza Parking Concession (5610) in the amount of \$12,000. These funds will be realized from concession operations and will be used to offset the aforementioned appropriation.

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance shall become effective upon its adoption.
