CAROLINA, AND CALLING A PUBLIC HEARING ON THE QUESTION

WHEREAS, the Community Development Department of the City of Charlotte, by and through its Director, has requested the City to vacate and close that certain portion of East 5th Street Extension in the City of Charlotte, Mecklenburg County, North Carolina, as same is shown on Boundary Survey entitled First Ward Urban Renewal Area, Project N.C. R-79, Street Abandonment of E. 5th Street Extension, prepared by Giddings & Associates dated September 4, 1975, a copy of which is available for inspection in the Office of the City Clerk in the City Hall at Charlotte, North Carolina; said portion of said street being more particularly described in Exhibit "A" attached hereto and made a part hereof; and

WHEREAS, the procedure for closing streets and public alleys as outlined in Chapter 160A, Section 299 of the General Statutes of North Carolina requires that Council first adopt a resolution declaring its intent to close the street or public alley and calling a public hearing on the question; said Statute further requires that the resolution shall be published once a week for four successive weeks prior to the hearing, and a copy thereof be sent by registered or certified mail to all owners of property adjoining the street or public alley as shown on the County tax records, and a notice of the closing and public hearing shall be prominently posted in at least two places along said streets or public alley; and

WHEREAS, the City of Charlotte is desirous of complying with the Petitioner's request.

NOW, THEREFORE, BE IT RESOLVED AND DECLARED by the City Council of the City of Charlotte, at its regularly scheduled session of November 3, 1975, that it intends to close that certain portion of East 5th Street Extension in the City of Charlotte, Mecklenburg County, North Carolina, as same is shown on Boundary Survey entitled First Ward Urban Renewal Area, Project N.C. R-79, Street Abandonment of E. 5th \$treet Extension, prepared by Giddings & Associates dated September 4, 1975, a copy of which is available for inspection in the Office of the City Clerk in the City Hall at Charlotte, North Carolina, said portion of said street being more particularly described in Exhibit "A" hereto attached and made a part hereof, and hereby calls a stion to be held at 3 P.M., on Monday the 8th day, 1975, in the Council Chamber of the City Hall. WHEREAS, the Redevelopment Plan for the Greenville Urban Renewal Project No. N. C. R-78, dated September, 1969, as subsequently Amended and Modified, has been duly approved by the City Council of the City of Charlotte and all public bodies, officials and agencies which, under State law, were required to authorize or approve the Redevelopment Plan and Amendments and Modifications thereto; and

WHEREAS, the Redevelopment Plan, as Amended and Modified, provides for the acquisition and complete clearance with few exceptions and redevelopment of the Project Area as a predominantly residential area; and

WHEREAS, all of the property in the Project designated to be acquired with the exception of one parcel for a street widening has now been acquired; and

WHEREAS, the major purpose of the Plan is to develop a full-service community containing all of the available social and economic necessities and amenities designed to provide a better living environment for the residents, including the construction by private developers of new housing facilities primarily for low and moderate income families and individuals; and

WHEREAS, the only practical and economic method through which low and moderate income housing can be constructed is under a Federally-assisted program; and

WHEREAS, the only Federally-assisted program presently available for the production of low and moderate income housing is the Section 8 Housing Assistance Payments Program; and

WHEREAS, 24 CFR 880.203(d) provides that upon request of a unit of general local government, a site, such as a Federal urban renewal project, may be predetermined or preapproved by a Field Office of the Department of Housing and Urban Development for a project under the Section 8 Housing Assistance Payments Program.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

That a request be and is hereby made to the Area Director, Greensboro Area Office of the Department of Housing and Urban Development, that the Greenville Urban Renewal Project No. N. C. R-78 be predetermined or preapproved in accordance with 24 CFR 880.203(d) as a site specifically designated for 200 units of housing under the Section 8 Housing Assistance Payments Program.

WHEREAS, the City of Charlotte has submitted an application in accordance with certain well-defined Federal objectives and has received approval from the United States of America for the execution of a comprehensive Community Development Program to be financed with Community Development Block Grant Funds; and

WHEREAS, one of the activities authorized to be assisted under the Community Development Program includes rehabilitation of residential, nonresidential and mixed-use properties in deteriorated or deteriorating areas, including interim assistance and financing rehabilitation of privately owned properties; and

WHEREAS, Community Development Block Grant Funds have been allocated for this purpose in the City of Charlotte; and

WHEREAS, there has been prepared and referred to the City Council of the City of Charlotte for review and approval a proposed Rehabilitation Grant and Loan Program and Conditions Under Which Grants or Loans May Be Made to Owners or Tenants of Residential Properties and Owners or Tenants of Nonresidential or Mixed-use Properties for use in the City of Charlotte Community Development Program.
