An Ordinance Amending the City Code with respect to the Zoning Ordinance

WHEREAS, the City Council of the City of Charlotte considering the use of the property described in Section 1 below for <u>Conditional Off-Street Parking in an R-6MF</u> <u>District</u> purposes finds that the proposed use of the site will conform to the requirements set by the Code of the City of Charlotte and will be generally compatible with nearby residential property and will generally conform to the development plan for the neighborhood.

Section 1. That, pursuant to the provisions of Chapter 23, Section 23-39 of the Code of the City of Charlotte, the following described property now zoned R-6MF is hereby granted approval for <u>Conditional Off-Street Parking in a Multi-Family</u> <u>Residential District</u> use to be developed in accordance with approved plans and associated requirements filed in the Office of the City Clerk of the City of Charlotte:

Section 2. That this ordinance shall become effective upon its adoption.



AMENDING CHAPTER 20 Section 20-51

ORDINANCE 457

AN ORDINANCE AMENDING CHAPTER 20, SECTION 20-51 OF THE CODE OF THE CITY OF CHARLOTTE.

BE IT ORDAINED by the City Council of the City of Charlotte, North

Carolina that:

<u>Section 1</u>. Section 20-51 of the City Code shall be amended by the deletion of the title in its entirety and substituting in lieu thereof the follow-ing new title:

"Sec. 20-51. Pedestrians soliciting from the street or median strip."

Sec. 2. Subsection (a) of Section 20-51 of the City Code shall be amended by inserting the words "or median strip" after the word "roadway" in the first sentence.

<u>Sec. 3.</u> Section 20-51 of the City Code shall also be amended by the addition of a new subsection "(c)" to read as follows:

"(c) It shall be unlawful for any person to stand, sit or loiter in any street or highway, including the shoulders or median strip but excluding sidewalks, and stop or attempt to stop any vehicle for the purpose of soliciting or accepting contributions from the occupants of any vehicle, or for the purpose of distributing merchandise or literature to the occupants of any vehicle."

Sec. 4. This ordinance shall become effective upon adoption.
