with respect to the Zoning Ordinance


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That Chapter 23, Section 23-8 of the Code of the City of Charlotte is hereby amended by changing from R-6MF to R-12MF on the Official Zoning Map, City of Charlotte, N. C. the following described property:

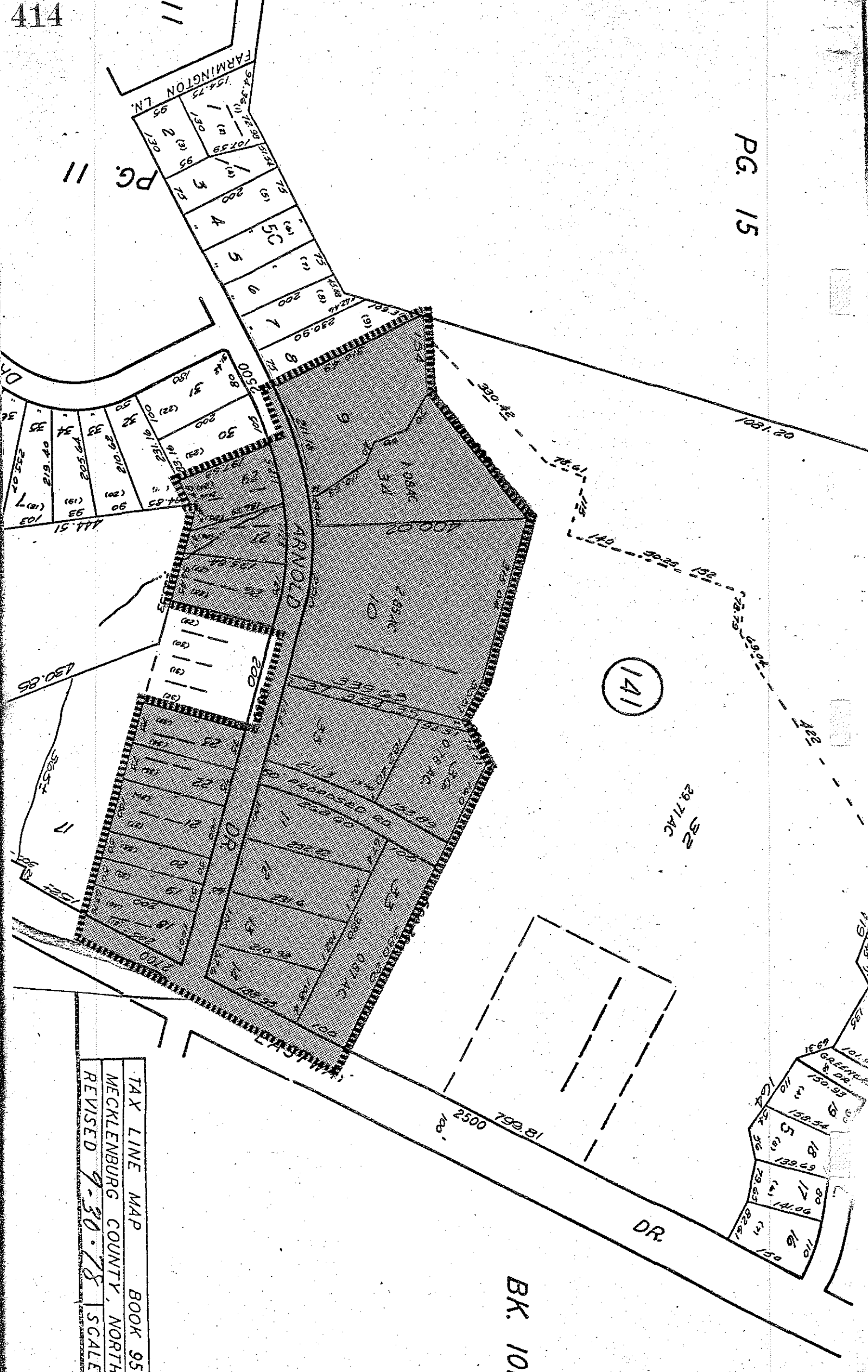
Section 2. That this ordinance shall become effective upon its adoption.

 REVISED 9-30-78 SCALE 1" = 20'

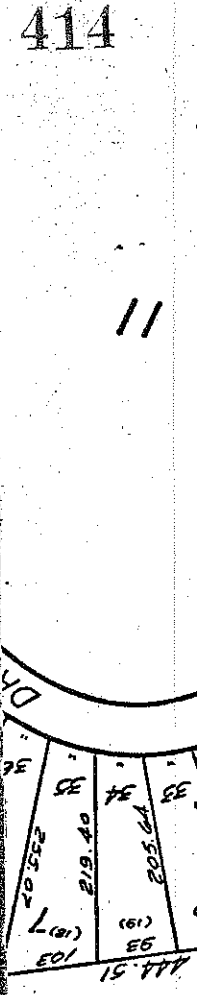
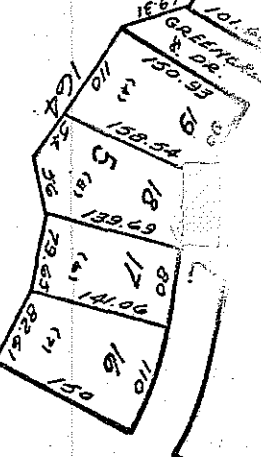

ORDINANCE NO. 464-X

AN ORDINANCE TO AMEND ORDINANCE NO. 91-X, THE 1978-79 BUDGET ORDINANCE, TO PROVIDE A SUPPLEMENTAL APPROPRIATION AND TO REVISE THE TABLE OF ORGANIZATION FOR THE ANIMAL CONTROL DEPARTMENT.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;


Section 1. That the sum of \$11,200 is hereby transferred from the General Fund Contingency to Account 404.00 - Animal Control Department. These funds will be used to finance improvements to the Animal Control Department's operation as recommended by the Mayor's Task Force.

Section 2. That the Table of Organization for the Animal Control Department should be amended to delete two (2) Senior Animal Control Officer (Class No. 3312) and add three (3) Animal Control Supervisor (Class No. 3312).

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance shall become effective upon its adoption.
