

ORDINANCE NO. 904-X

AN ORDINANCE TO ESTABLISH REVENUE ESTIMATES FROM THE NORTH CAROLINA DEPARTMENT OF TRANSPORTATION AND TO PROVIDE AN APPROPRIATION TO FINANCE TRAFFIC SIGNAL IMPROVEMENTS.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1. That the sum of \$6,275 is hereby estimated to be available under a municipal agreement between the City of Charlotte and the North Carolina Department of Transportation.

Section 2. That the sum of \$6,275 is hereby appropriated to the General Capital Improvement Project Fund Account 393.00 - Traffic Signal Improvements. This municipal agreement will provide funds to finance the installation of a traffic signal at the intersection of Graham Street and Norris Avenue.

Section 3. That the Finance Director or his designate is hereby authorized to make \$6,275 available from the unappropriated balance of the General Revenue Sharing Fund in advance of the receipt of State grant funds. These funds shall be repaid upon receipt of State funds.

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. This ordinance shall become effective upon its adoption.

ORDINANCE NO. 905-X

AN ORDINANCE TO AMEND ORDINANCE NO. 576-X, THE 1977-78 BUDGET ORDINANCE, TRANSFERRING FUNDS FROM THE UNAPPROPRIATED BALANCE OF THE 1972 AIRPORT GENERAL OBLIGATION BOND FUND AND ESTIMATING SUPPLEMENTAL FEDERAL GRANT FUNDS TO PROVIDE A SUPPLEMENTAL APPROPRIATION FOR THE CONSTRUCTION OF THE NORTH/SOUTH PARALLEL RUNWAY AT DOUGLAS AIRPORT.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1. That the sum of \$1,647,382 is needed to complete the financing of the North/South Parallel Runway, as follows:

Section 2. That the sum of \$457,382 is estimated to be available from the following sources pending the execution of a grant agreement with the Federal government:

Section 3. That the sum of \$96,845 is hereby transferred from the unappropriated balance of the 1972 Airport General Obligation Bond Fund to finance the supplemental local share for the construction of the North/South Parallel Runway.

Section 4. That the Finance Director or his designate is hereby authorized to make \$1,235,537 available from the unappropriated balance of the 1972 General Obligation Bond Fund in advance of the execution of a grant agreement with the Federal government. These funds shall be repaid upon receipt of Federal grant funds.

Section 5. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 6. This ordinance shall become effective upon its adoption.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;



BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;



AN ORDINANCE TO ESTIMATE FEDERAL, STATE AND LOCAL REVENUES AND TO ESTABLISH AN APPROPRIATION TO FINANCE THE CONSTRUCTION OF PHASE II OF THE METRO CHARLOTTE 201 WASTEWATER FACILITIES PROJECTS.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1. That the sum of \$28,900,000 is hereby estimated to be available as a result of a Federal Environmental Protection Agency Grant, a State Clean Water Grant, and the issue of sanitary sewer bonds for EPA projects to construct the Metro Charlotte 201 Wastewater Facilities Project-Phase II in accordance with the following schedule:



Section 2. That the sum of \$28,900,000 is hereby appropriated to the Utilities Capital Improvement Projects Fund 2071, Account 632.24 - Phase II-Construction of Metro Charlotte 201 Projects. These funds will be used to finance the construction of the McAlpine Creek Plant upgrading, Sugar Creek Interceptor, Toby Creek Interceptor, and Matthews Interceptor.
