Department of Transportation in accord with the provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of an application for assistance under the Urban Mass Transportation Act of 1964, as Amended, the applicant give an assurance that it will comply with Title VI of the Civil Rights Act of 1964 and the U. S. Department of Transportation requirements thereunder;

WHEREAS, it is the goal of the City of Charlotte that minority business enterprise be utilized to the fullest extent possible in connection with this project, and that definitive procedures shall be established and administered to ensure that minority businesses shall have the maximum feasible opportunity to compete for contracts when procuring construction contracts, supplies, equipment contracts, or consultant and other services; and

WHEREAS, the City of Charlotte realizes the need for certain additional capital items to upgrade the Charlotte Transit System:

NOW, THEREFORE, BE IT RESOLVED by the City Council of Charlotte, North Carolina that;

- 1. The City Manager is authorized to file and execute a capital grant application in accordance with Charlotte's Transit Development Program and Transportation Improvement Program for fiscal year 1979-80, on behalf of the City of Charlotte, North Carolina, with the U.S. Department of Transportation and North Carolina Board of Transportation for the purchase of advanced design buses, specialized transportation vehicles, radio system improvements, shop tools and equipment, office equipment and furniture, service vehicles, bus passenger shelters and benches, bus stop signs and information boards, and other miscellaneous improvements.
- That the City Manager is authorized to execute and file with such application any assurances or any other documentation required by the U. S. Department of Transportation or North Carolina Board of Transportation effectuating the purpose of Title VI of the Civil Rights Act of 1964.
- 3. That the Transit Planning Coordinator is authorized to furnish such additional information as the U.S. Department of Transportation of North Carolina Board of Transportation may required in connection with the project.

- That the City Manager is authorized to set forth and execute affirmative minority business policies in connection with the project's procurement needs.
- 5. That, upon approval of this application by the U.S. Department of Transportation, or North Carolina Department of Transportation, Charlotte's Mayor or Mayor Pro-tem is hereby authorized to sign and comply with the terms of any new or changed contracts for this project on behalf of the City of Charlotte.
