IN CONFORMANCE WITH THE HOUSING ASSISTANCE PLAN**


WHEREAS, the Charlotte City Council approved in its Housing Assistance Plan certain guidelines for the location of public assisted housing; and

- (3) Class Number 3610, Airport Security Chief, is added and assigned to pay range 19, pay steps A-F.

RESOLUTION AMENDING THE PAY PLAN,  
EMPLOYEE GROUP INSURANCE PLAN,  
AND PERSONNEL RULES AND REGULATIONS

BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina, that:

- (1) The Pay Plan heretofore adopted by the City Council to become effective October 1, 1960, as subsequently amended, be hereby further amended as follows:
  - (a) The pay plan recommendations presented in the report entitled FY 80, Recommended Salary and Benefit Adjustments be adopted in their entirety, except that existing pay rates be increased by 6.75 percent, and the pay rates currently in effect for all City employees be adjusted accordingly; and except that the pay supplement for first responder duties of Firefighters, Firefighter-Engineers, and Fire Captains certified as Emergency Medical Technicians be set at \$42.50 monthly (\$9.81 weekly).
  - (b) Class No.3032, Fire Investigator, pay range 18, steps A-F is deleted; Class No.3032, Fire Investigator I, pay range 16, steps A-F is added; Class No.3033, Fire Investigator II, pay range 18, steps A-F is added;
  - (c) The pay range assignment of Class No.2745, Chief Park Ranger, be increased from pay range 15 to pay range 16.
- (2) The revisions to the group insurance plan, as presented in the report entitled FY 80, Recommended Salary and Benefit Adjustments be adopted in their entirety;
- (3) The Personnel Rules and Regulations heretofore adopted by the City Council to be effective October 6, 1969, as subsequently amended are hereby further amended as follows:
  - (a) Rule III, Pay Plan; Section 5, Use of Pay Ranges be amended to read in its entirety as follows:

The pay ranges are intended to furnish administrative flexibility in recognizing individual differences between positions allocated to the same class, in providing employee incentives, in rewarding employees for meritorious service, and in meeting emergency conditions requiring pay adjustments.

Salary increases within appropriate ranges shall normally be from one step to the next higher step. Upon successful completion of the probationary period, employees will be advanced to the next higher step. Thereafter, salary increases within appropriate ranges shall normally be granted at intervals of fifty-two weeks of meritorious job performance. However, salary increases at intervals of less than fifty-two weeks, or of more than one step within the appropriate range, may be granted upon the recommendation of the department head concerned, review by the Personnel Director, and the final approval of the City Manager.

- (b) Rule V, Retirement Policy, Sections 1, 2 and 3 be deleted in their entirety and the following Section 1 be substituted in lieu thereof:

Section 1. Mandatory Retirement Age

- (a) Excluding disability or voluntary early retirement, all City employees, with the exception of Firefighters and Fire Officers, shall be retired from the City's service upon reaching the age of 70. Retirement shall be mandatory on the last day of the month in which the employee attains that age.
- (b) Excluding disability or voluntary early retirement, all Firefighters and Fire Officers, shall be retired from the City's service upon reaching the mandatory retirement age set forth in their retirement system.

It is furthermore recommended that Section 4, Pre-Retirement Counseling, be renumbered as Section 2.

RESOLUTION AUTHORIZING THE REVERSION TO THE CITY OF CHARLOTTE  
OF THE ATTACHED LOTS IN ELMWOOD CEMETERY BECAUSE OF COMPLIANCE  
WITH SECTION 7-4 OF THE CHARLOTTE CITY CODE

WHEREAS, Section 7-4 of the Charlotte City Code provides that, when a lot remains without any interment for twenty (20) years and the owner and relatives are unknown to the City Council, the city can give notice once a week for four (4) weeks in a newspaper published in the city, in compliance with Section 7-4 (b), to have said lots revert in ownership to the City of Charlotte for future interment; and

WHEREAS, on 12 February 1979 the Charlotte City Council authorized the City Clerk to advertise the intent of the City Council to have certain designated lots in Elmwood Cemetery revert to the City which have not been used for at least seventy (70) years; and

WHEREAS, notice of publication has occurred for four (4) weeks on April 2, 10, 18, and 27 in 1979 in a newspaper published in the city and affidavits of publication have been received by the city's legal department; and

WHEREAS, the City of Charlotte has complied fully with all requirements of Section 7-4 (b) of the Charlotte City Code; and

WHEREAS, there is attached a list of those lots that have been the subject of a notice of publication and for which no claim of ownership has been presented;

NOW, THEREFORE, BE IT RESOLVED by the Charlotte City Council;

1. That the lots attached to this resolution have reverted in ownership to the City of Charlotte and the lots shall be listed in the minutes.
2. That the Supervisor of the Cemeteries is directed and authorized by the Charlotte City Council to proceed to offer for sale those lots and to regulate the interment of those lots consistent with City policy.
3. That any individual who shows after 25 June 1979, the effective date of the reversion of those lots to the City of Charlotte, any legal right to any such lot shall still be entitled, at no cost, to a comparable number of burial lots in another municipal cemetery of this City.
4. That the Supervisor of the Cemeteries Division is hereby authorized and directed to execute all necessary documents required for future interments of the lots included in this resolution and any transactions required to carry out the purpose and intent of this resolution.

RESOLUTION CALLING FOR A PUBLIC HEARING TO CONSIDER A PROPOSAL  
BY MOTION, INC. FOR THE PURCHASE OF THREE SINGLE-FAMILY  
LOTS LOCATED IN THE GRIER HEIGHTS NEIGHBORHOOD STRATEGY AREA

WHEREAS, under the authority of Article 22 of Chapter 160A of the General Statutes of North Carolina, and particularly 160A-513 of the General Statutes, the City of Charlotte has prepared a Redevelopment Plan for the Grier Heights Neighborhood Strategy Area; and

WHEREAS, the Redevelopment Plan has been approved by the Charlotte-Mecklenburg Planning Commission and the City Council of the City of Charlotte; and

WHEREAS, the City of Charlotte is authorized, pursuant to North Carolina Urban Redevelopment Law, to sell real property to private redevelopers in a Project Area; and

WHEREAS, the City of Charlotte has received a proposal in accordance with G. S. 160A-514(e)(4) from Motion, Inc., a non-profit organization, to purchase three parcels of property and construct three single-family houses thereon, identified as Block No. 13, Parcel No. 1, located on the southeast corner of Leroy Street and Tross Street; Block No. 16, Parcels Nos. 8 & 9, located on the northeast corner of Marney Avenue and Tross Street on a "Land Acquisition & Boundary Map, Grier Heights Community Development Target Area, Community Development Department, The City of Charlotte, Charlotte, North Carolina," prepared by Eric Hill Associates, Inc., Planning Consultants, dated September, 1975; and

WHEREAS, N. C. G. S. 160A-514(e)(4) requires that the City Council shall hold a public hearing prior to a negotiated sale and conveyance of redevelopment project land to a non-profit association or corporation.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

1. That on Monday, July 16, 1979, at 3:00 p.m., in the City Council Chamber of the City Hall, the City Council shall hold a public hearing in accordance with G. S. 160A-514(e)(4) to consider the proposal of Motion, Inc. to purchase by negotiation three parcels of property in the Grier Heights Neighborhood Strategy Area and construct three single-family houses thereon, all in accordance with the Redevelopment Plan for the Grier Heights Neighborhood Strategy Area.

2. That said map is on display at the office of the Community Development Department of the City of Charlotte and additional information may be obtained from the office of the Community Development Department at Suite 510, 301 South McDowell Street, Telephone 374-2016.

3. That this Resolution shall be published at least once a week for two consecutive weeks in The Charlotte News, a newspaper of general circulation in the City of Charlotte, North Carolina, the first publication to be not less than fifteen (15) days prior to the date fixed for said hearing.



NORTH CAROLINA

WHEREAS, NCNB Community Development Corporation has filed a Petition to close a portion of North Pine Street in the City of Charlotte; and

WHEREAS, the portion of North Pine Street petitioned to be closed lies between West Ninth Street and West Tenth Street as shown on a map marked "Exhibit A", and is more particularly described by metes and bounds in a document marked "Exhibit B", both of which are available for inspection in the Office of the City Clerk, City Hall, Charlotte, North Carolina; and


WHEREAS, the procedure for closing streets and alleys as outlined in North Carolina General Statutes, Section 160A-299, requires that Council first adopt a resolution declaring its intent to close the street and calling a public hearing on the question; said Statute further requires that the resolution shall be published once a week for four successive weeks prior to the hearing, and a copy thereof be sent by registered or certified mail to all owners of property adjoining the street as shown on the county tax records, and a notice of the closing and public hearing shall be prominently posted in at least two places along said street;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, at its regularly scheduled session of June 25th, 1979, that it intends to close a portion of North Pine Street lying between West Ninth Street and West Tenth Street, said portion thereof being more particularly described on a map and by a metes and bounds description available for inspection in the City Clerk's Office, and hereby calls a public hearing on the question to be held at 3:00 p.m., on Monday, the 30th day of July, 1979, in the Council Chamber of City Hall. The City Clerk is hereby directed to publish a copy of this resolution in the Mecklenburg Times once a week for four successive weeks next preceding the date fixed here for such hearing, as required by N.C.G.S. 160A-299, and further, the petitioner is directed to send by registered or certified mail a copy of this resolution to all owners of property adjoining the said street (or portion thereof) as shown on the county tax records. The petitioner is also directed to prominently post a notice of the closing and public hearing in at least two places along the portion of North Pine Street to be closed.

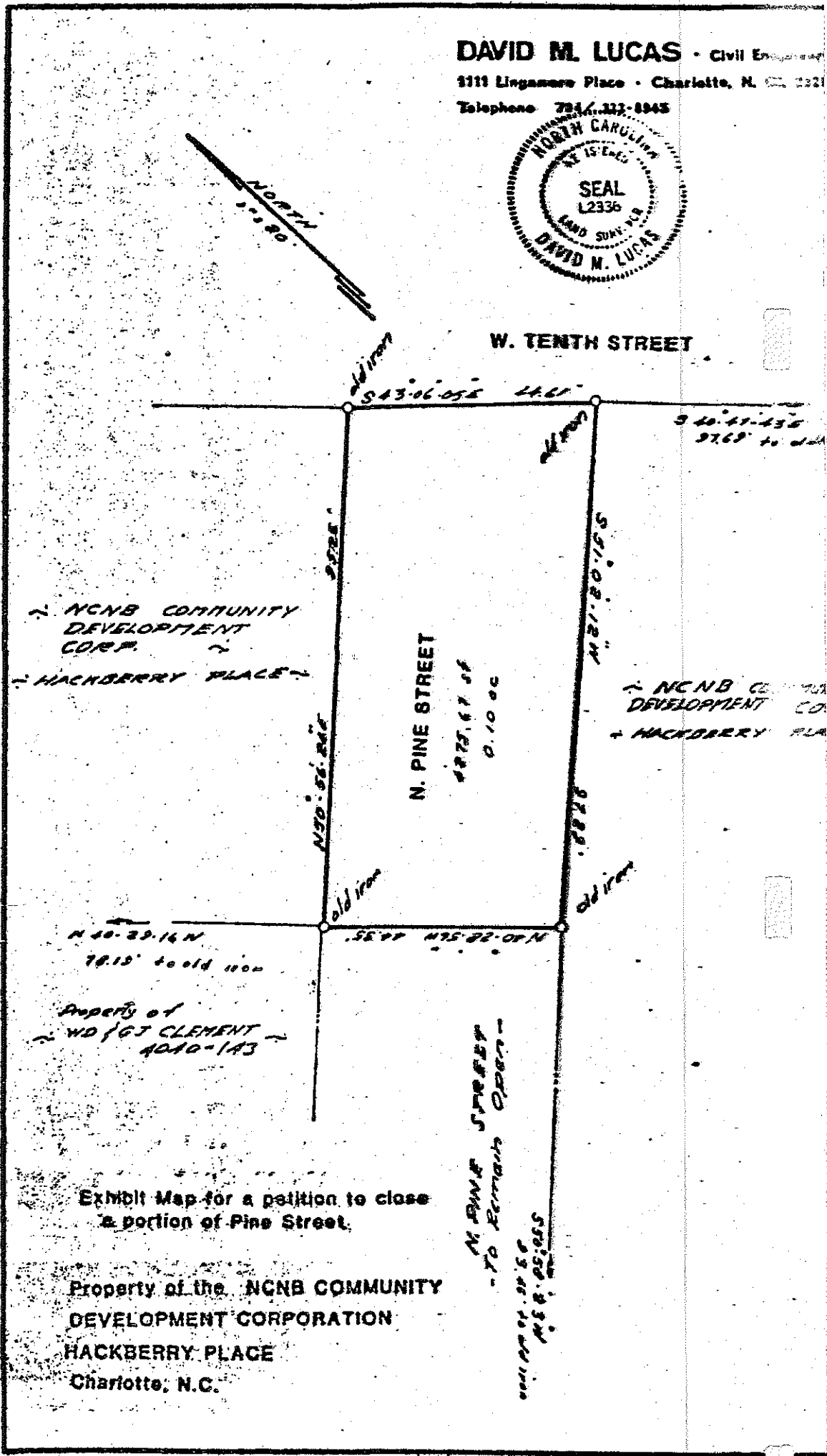
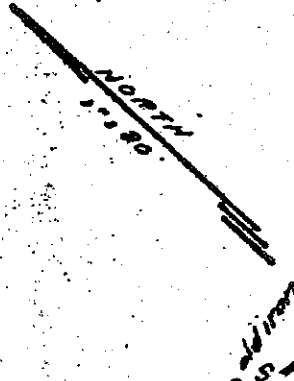
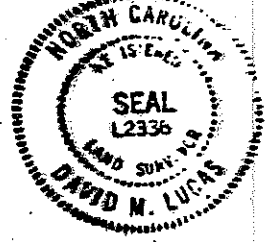
