To Be Abandoned A Portion of Jefferson St.", prepared by Community Development Department of the City of Charlotte, dated August, 1978, and that certain portion of Jefferson Street in the City of Charlotte, Mecklenburg County, North Carolina, as same is shown on a plat entitled "R.O.W. To Be Abandoned A Portion of Jefferson St.", prepared by Community Development Department of the City of Charlotte, dated March, 1978, and that certain portion of Quincey Street in the City of Charlotte, Mecklenburg County, North Carolina, as same is shown on a plat entitled "R.O.W.
