ORDINANCE NO. 940-X

AN ORDINANCE TO AMEND ORDINANCE NO. 394-X, THE 1980-81 BUDGET ORDINANCE TO INCREASE THE REVENUE AND EXPENDITURE ESTIMATES FOR PARK AND RECREATION.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1. That the General Fund revenue estimates for Charges for Services - Facility Fees and Charges are hereby revised and increased by \$42,000

Section 2. That the sum of \$42,000 is hereby appropriated to the Park and Recreation; Park Center/Stadium Account 300.05.549 for the improvement of the concession areas.

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

ORDINANCE NO. 941-X

AN ORDINANCE TO AMEND ORDINANCE NO. 394-X, THE 1980-81 BUDGET ORDINANCE, TRANSFERRING FUNDS FROM THE UNAPPROPRIATED BALANCE OF THE COUNTY SEWER BOND FUND TO PROVIDE AN APPROPRIATION FOR PURCHASE OF SEWER MAINS.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1. That the sum of \$281,600.95 is hereby transferred from the unappropriated balance of the County Sewer Bond fund to the Purchase of Sewer Mains account (633.01). These funds will be used to pay an obligation on a refundable sewer main extension contract.

ORDINANCE NO. 942-X

AN ORDINANCE TO AMEND ORDINANCE NO. 394-X, THE 1980-81 BUDGET ORDINANCE ESTIMATING REVENUES AND ESTABLISHING AN APPROPRIATION FOR TRAINING ACTIVITIES IN THE POLICE DEPARTMENT.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1. That the sum of \$6,536 is hereby estimated to be available from the following sources:

Governor's Highway Safety Program	\$5,229
City Match (401.41.163)	<u>1,307</u>
Total	6,536

Section 2. That the sum of \$6,536 is hereby appropriated to the following accounts:

531.59 Southern Police Administration	\$3,636
531.60 Police Traffic Administration	<u>2,900</u>
Total	6,536

These funds will provide for attendance by Police Officers in professional training courses.

Section 3. It is anticipated that these projects will extend beyond the FY81 budget ordinance and will remain in effect for the duration of the project.
