WHEREAS, the petitioner agrees to cause the relocation of the sewer main and provide a fifteen (15) foot right of way to be dedicated for the operation and maintenance of said sewer main; and,

WHEREAS, the petitioner agrees to cause the abandonment and/or relocation of the aforementioned items, the petitioner agrees to incur the cost of the construction.

BE IT FURTHER RESOLVED, that the Council develop a plan to implement the appointments on a one-third to two-thirds (1/3-2/3's) basis over a period of time for all boards and commissions.
