WHEREAS, a Petition has been filed and received in accordance with the provisions of Chapter 160A, Section 299 of the General Statutes of North Carolina, requesting the closing of certain portions of Lincoln, West Palmer, and Church Streets in the City of Charlotte, Mecklenburg County, North Carolina; and

WHEREAS, the City Council has caused to be published a Notice of Public Hearing, all in accordance with said Statute; and

WHEREAS, said public hearing was held on the 23rd day of <u>March</u>, 1981; and

WHEREAS, the City of Charlotte owns all of the land adjoining the affected portions of the above-mentioned streets with the exception of a portion adjoining Lincoln Street owned by James L. Griffin (A & A Brass Co.) and portions adjoining West Palmer Street owned by Mr. and Mrs. Chris Economides, Jr. and Tops Petroleum Corp.; and

WHEREAS, no persons, firms, or corporations or parties in interest have appeared in opposition to the closing of said portions of said streets;

THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina:

That the Council hereby orders the closing of that certain portion of Lincoln Street in the City of Charlotte, Mecklenburg County, North Carolina, as same is shown on a plat entitled "R/W To Be Abandoned Lincoln Street West Morehead Community Development Strategy Area", prepared by City of Charlotte, Department of Public Works, Engineering Division, dated August 28, 1980, and that certain portion of West Palmer Street in the City of Charlotte, Mecklenburg County, North Carolina, as same is shown on a plat entitled "R.O.W. To Be Abandoned A Portion of W. Palmer Street West Morehead Community Development Strategy Area", prepared by City of Charlotte, Department of Public Works, Engineering Division, dated July 28, 1980, and that certain portion of Church Street in the City of Charlotte, Mecklenburg County, North Carolina, as same is shown on a plat

> entitled "R/W To Be Abandoned Portion of So. Church Street West Morehead Community Development Strategy Area", prepared by City of Charlotte, Engineering Department, dated March, 1978, Revised September 11, 1980, copies of which are hereto attached and marked Exhibits "A" through "C" and incorporated by this reference, said portions of said streets being more particularly described in Exhibit "D" hereto attached and made a part hereof, it appearing to the satisfaction of the City Council that the closing of those portions of said streets is not contrary to the public interest and that no individual, firm, or corporation owning property in the vicinity thereof will be deprived of reasonable means of ingress and egress to his or its property.






