A fifteen-foot sanitary sewer easement shall be reserved and recorded in the abandoned portion of North Long Street.

R-79", prepared by City of Charlotte, Department of Public Works, Engineering Division, dated January 20, 1981, and that certain portion of Haley Place in the City of Charlotte, Mecklenburg County, North Carolina, as same is shown on a plat entitled "Right-of-Way To Be Abandoned Haley Place, First Ward Urban Renewal Area, Project No. N.C. R-79", prepared by City of Charlotte, Department of Public Works, Engineering Division, dated January 20,

1981, copies of which are hereto attached and marked Exhibit "A" and "B" and incorporated by this reference, said portions of said streets being more particularly described in Exhibit "C" hereto attached and made a part hereof, it appearing to the satisfaction of the City Council that the closing of those portions of said streets is not contrary to the public interest and that no individual, firm, or corporation owning property in the vicinity thereof will be deprived of reasonable means of ingress and egress to his or its property.

BE IT FURTHER RESOLVED that a certified copy of this Resolution be filed in the Office of the Register of Deeds for Mecklenburg County, North Carolina.


