A regular meeting of the City Council of the City of Charlotte, North Carolina was held at the Education

Center at 6:00 P.M., on August 15, 1983, Mayor Pro Tem Harvey B. Gantt presiding, and the following Councilmembers being present:

Councilmember Selden introduced

the following three orders authorizing bonds which were read
by title and summarized by the Assistant City Attorney:

ORDER AUTHORIZING \$13,450,000 STREET IMPROVEMENT BONDS

BE IT ORDERED by the City Council of the City of Charlotte:

Section 1. That, pursuant to The Local Government Bond Act, as amended, the City of Charlotte, North Carolina, is hereby authorized to issue Street Improvement Bonds in an aggregate principal amount not exceeding \$13,450,000 for the purpose of providing funds, with any other available funds, for paving, grading, resurfacing and widening streets and constructing sidewalks in said City, including the acquisition of any necessary land and rights of way.

Section 2. That taxes shall be levied in an amount sufficient to pay the principal of and the interest on said bonds.

Section 3. That a sworn statement of the debt of the City has been filed with the Clerk and is open to public inspection.

Section 4. That this order shall take effect when approved by the voters of the City at a referendum as provided in said Act.

ORDER AUTHORIZING \$3,050,000 WATER BONDS

BE IT ORDERED by the City Council of the City of Charlotte:

Section 1. That, pursuant to The Local Government Bond Act, as amended, the City of Charlotte, North Carolina, is hereby authorized to issue Water Bonds in an aggregate principal amount not exceeding \$3,050,000 for the purpose of providing funds, with any other available funds, for enlarging and extending the water system of said City, including the installation of water mains and lines, the improvement of filtration facilities, the acquisition of necessary rights of way and equipment and the payment of an outstanding revenue bond anticipation note.

Section 2. That taxes will be levied in an amount sufficient to pay the principal of and the interest on said bonds.

Section 3. That a sworn statement of the debt of the City has been filed with the Clerk and is open to public inspection.

Section 4. That this order shall take effect when approved by the voters of the City at a referendum as provided in said Act.

ORDER AUTHORIZING \$30,460,000 SANITARY SEWER BONDS

BE IT ORDERED by the City Council of the City of Charlotte:

Section 1. That, pursuant to The Local Government Bond Act, as amended, the City of Charlotte, North Carolina,

is hereby authorized to issue Sanitary Sewer Bonds in an aggregate principal amount not exceeding \$30,460,000 for the purpose of providing funds, with any other available funds, for enlarging and extending the sanitary sewer system of said City, including the expansion of existing treatment facilities, the elimination of existing lift stations, the construction and improvement of sanitary sewer outfalls, mains and lines, the acquisition of necessary land, rights of way and equipment, and the payment of an outstanding revenue bond anticipation note.

Section 2. That taxes will be levied in an amount sufficient to pay the principal of and the interest on said bonds.

Section 3. That a sworn statement of the debt of the City has been filed with the Clerk and is open to public inspection.

Section 4. That this order shall take effect when approved by the voters of the City at a referendum as provided in said Act.

Thereupon, on motion duly made, seconded and unanimously carried, the City Council designated the Director of Finance as the officer to make and file with the Clerk the sworn statement of debt of the City which is required by The Local Government Bond Act, as amended, to be filed before the public hearing on the orders which were introduced at this meeting.

Thereupon the Director of Finance filed with the Clerk, in the presence of the City Council, the sworn statement of debt as so required.

Thereupon the order entitled: "ORDER AUTHORIZING \$13,450,000 STREET IMPROVEMENT BONDS" was passed on first reading.

Thereupon the order entitled: "ORDER AUTHORIZING \$3,050,000 WATER BONDS" was passed on first reading.

Thereupon the order entitled: "ORDER AUTHORIZING \$30,460,000 SANITARY SEWER BONDS" was passed on first reading.

On motion duly made, seconded and unanimously carried, the City Council fixed 7:30 P.M., September 12, 1983, at Starmount Elementary as the hour, day and place for the public hearing upon the foregoing orders and directed the Clerk to publish each of said orders, together with the appended note as required by The Local Government Bond Act, as amended, in The Charlotte Observer not later than the sixth day before said date.

AMENDING CHAPTER 23

AN ORDINANCE AMENDING THE CITY CODE WITH RESPECT TO THE ZONING ORDINANCE.

WHEREAS, a petition was presented to the City Council of the City of Charlotte requesting the rezoning of a 17.773 acre site located 1210 feet from Sharon Road along the southwestern side of Quail Hollow Road and also fronting on Sharon Hills Road from R-15 to R-15MF(CD); and

WHEREAS, the petition for rezoning for a parallel conditional use district as permitted by Section 23-35.1 was submitted to the Charlotte-Mecklenburg Planning Commission, was accompanied by a schematic plan, complied with all the application requirements as specified in Section 23-35(b), and was recommended for approval by the Charlotte-Mecklenburg Planning Commission; and

WHEREAS, the City Council has authority to amend the Zoning Ordinance by Section 23-96 and a public hearing was held on January 10, 1983; and

WHEREAS, in the passage of this ordinance the City Council of the City of Charlotte has considered the promotion of the health, safety, general welfare, and public interest of the community, and each of the following which are required by Section 23-35(d):

- 1. The policies and objectives of the Comprehensive Plan of the City, and particularly in relation to the proposed site and surrounding area.
- 2. The potential adverse impacts of the establishment of the conditional district upon the surrounding area, especially in regards but not limited to traffic, storm drainage, land values and compatibility of land use activities.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That Chapter 23, Section 23-8 of the Code of the City of Charlotte is hereby amended by changing from R-15 to R-15MF(CD) on the Official Zoning Map, City of Charlotte, N. C. the following described property:

TRACT 1

Section 2. That all subsequent development and use of the property shall be in accordance with the approved plan.

Section 3. That this ordinance shall become effective upon its adoption.
