ORDINANCE NO. 1312-X

AN ORDINANCE TO AMEND ORDINANCE NO. 1184-X, THE 1982-83 BUDGET ORDINANCE, ESTIMATING REVENUE FROM RABIES INOCULATION AND APPROPRIATING THESE FUNDS TO THE OPERATIONS DEPARTMENT.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1: That the sum of \$44,000 is hereby estimated to be available from payments by citizens for rabies inoculation of their animals.

Section 2: That the sum of \$44,000 is hereby appropriated to the Operations Department, Animal Control Division (404.00.179) to reimburse veterinarians for the rabies inoculation that they have administered.

Section 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4: This ordinance shall become effective upon its adoption.


BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1. That the sum of \$937,500 is hereby estimated to be available from State Grant SBH-1134 to be appropriated to Fund 2071; Account 634.02 (Hoskins Water Treatment Plant Clearwell). Funds will be used to construct a 12 million gallon clearwell at Hoskins Water Treatment Plant.

Section 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

AMENDING CHAPTER 11

ORDINANCE 1314

AN ORDINANCE AMENDING CHAPTER 11, ENTITLED "LICENSES" OF THE CITY CODE RELATIVE TO CHANGES IN PRIVILEGE LICENSE TAXES.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina that:

Section 1. Section 11-6 of Chapter 11 of the City Code shall be deleted in its entirety, and the following substituted in lieu thereof:

"Sec. 11-6. Free licenses prohibited; exceptions.

No free licenses shall be granted for peddling except to disabled veterans; provided, however, such peddling is done on foot and not from any vehicle. Any such person must be a resident of North Carolina for at least twelve (12) months in order for the license to be granted."

Sec. 2. Section 11-18 of Chapter 11 shall be amended by the addition of a new subsection to classification 116 to read as follows:

"(c) Every person, firm or corporation engaged in the business of selling wholesale and having no place of business, but selling to retail dealers by use of some form of vehicle . . . . . \$25.00"

Sec. 3. Section (1) shall become effective upon adoption and Section (2) shall become effective July 1, 1983.
