ORDINANCE NO. 1437

AMENDING CHAPTER 10

AN ORDINANCE AMENDING CHAPTER 10, ENTITLED "HEALTH AND SANITATION", OF THE CODE OF THE CITY OF CHARLOTTE.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina, that:

Section 1. Chapter 10, Article II, § 24, "City of Charlotte Landfill Fee Schedule", subsection (B), "Exemption", of the City Code shall be amended by adding the following new paragraphs after the paragraph in Code § 10-24(B) ending in the words " . . . to carry out the purposes of such institutions." and before the beginning of Code § 10-24(C) to read as follows:

"In addition, the Director of the Operations Department of the City shall have the authority to grant an exemption from the City of Charlotte's Landfill Fee Schedule in a particular situation upon making the following findings:

- 1. That the debris or refuse to be brought to a City landfill represents a clean up of a community blight or community problem that benefits the public-at-large.
- 2. That the exemption in no way represents an avoidance of the intent or the spirit of the City of Charlotte Landfill Fee Schedule by benefiting any private or commercial interest rather than the public-at-large.
- 3. That the clean up is done by volunteers or a non-profit entity who have undertaken such a clean up in the public's interest and the landfill fee schedule represents a financial obstacle in getting rid of the debris or refuse.
- 4. That the cost to the City for using its own trucks and employees for picking up the debris or refuse and disposing of it substantially exceeds having volunteers do it and providing an exemption under the City Landfill Fee Schedule.
- 5. That approval is given for each situation individually and the primary purpose is to facilitate a clean up for a particular project.

The Director of Operations shall approve any exemption in writing stating the information supporting the findings that are necessary to grant the exemption. The reports granting exemptions shall be kept on file in the Operations Department and shall be reviewed annually by the Internal Audit Section of the Finance Department in order to ensure that the required findings have been made in order to grant the exemptions. The determination of the Director of the Operations Department about granting or denying an exemption shall be final and there shall be no appeals to the City Council."

Section 2. This ordinance shall be effective upon its adoption.
