A RESOLUTION ESTABLISHING THE CITIZENS' ADVISORY COUNCIL FOR HAZARDOUS CHEMICALS

WHEREAS, the Mayor's Chemical Safety Blue Ribbon Committee recently completed its study resulting in several recommendations to develop and formulate plans for the identification, storage, use, handling and transportation of hazardous chemicals in the City of Charlotte; and

WHEREAS, one of the recommendations of this committee was the establishment of a Citizens Safety Council for Hazardous Chemicals to be comprised of representatives and specialists from local businesses or agencies in the community concerned with, but not limited to, environmental health, medicine, chemicals, transportation, hazardous material storage and handling, engineering (with fire protection expertise), and public information/education; and

WHEREAS, a council of citizens with expertise in the fields set out above can play a valuable advisory role in the reviewing and identifying of potentially hazardous situations in the community, as well as the City's chemical storage, handling and transportation programs.

NOW, THEREFORE, BE IT RESOLVED that the City Council hereby establishes a Citizens Advisory Council for Hazardous Chemicals whose charge shall be as follows:

1. Provide community expertise with regard to reviewing and identifying potentially hazardous situations in the community relating to the storage, use, handling and transportation of chemicals.

- 2. Act as a steering committee in close cooperative work with a coordinator to consider provisions for the assistance of local industry in developing effective and efficient programs dealing with hazardous materials, including, but not limited to the development of training programs, equipment and technical assistance availability, and the review or recommendation of ordinances deemed necessary to implement such programs.
- 3. Make an annual report to the City Council of its activities which shall include a review of existing programs and recommendations.

The Citizens Advisory Council for Hazardous Chemicals shall consist of seven members, five appointed by Council and two appointed by the Mayor, each appointed to three-year staggered terms, with no person to serve more than two full consecutive terms. The initial appointments shall be as follows: two for one-year terms, two for two-year terms; and three for three-year terms; thereafter all terms shall be for three years. In case of a vacancy on the Council, the City Council or the Mayor, as the case may be, shall fill such vacancy for the unexpired term of such member.

The members of the Citizens Safety Council for Hazardous Chemicals shall consist of recognized leaders or specialists in environmental health, medicine, chemicals, transportation, hazardous material storage, use and handling, engineering (with fire protection expertise) and public information/education or any related field.

The Chairman of the Council shall be elected annually by the members and shall serve for a one-year term only. Any member of the Council who fails to attend at least seventy-five percent (75%) of the regular and special meetings held during any one year period shall be automatically removed from said Council.

"RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHARLOTTE FOR CONDEMNATION ACTION IN THE FIVE POINTS NEIGHBORHOOD STRATEGY AREA"

WHEREAS the City of Charlotte has undertaken the Redevelopment of the Five Points Neighborhood Strategy area, an Urban Redevelopment Project, in accordance with the provisions of Article 22 of Chapte 160A of the General Statutes of North Carolina; and

WHEREAS the Urban Redevelopment Law as set out in said Article and Chapter provides for the acquisition, preparation, sale, sound replanning, and redevelopment of property within a redevelopment area, as defined by said law; and

WHEREAS such area has been established in accordance with the requirements of such law and the said Five Points Neighborhood Strategy Area approved by the Governing Body of the City of Charlotte; and

WHEREAS such law specifically provides for the exercise of power of Eminent Domain in order to achieve and accomplish the purpose of the law as set out in said Article 22 of Chapter 160A, such purpose being in the public interest and designed to promote the health, safety and welfare of the inhabitants of this community and locality; and

WHEREAS the City of Charlotte, pursuant to the applicable laws and regulations, has endeavored to establish a fair market value on properties within the area, and has made a good faith effort through its proper agents to negotiate for the acquisition of properties within the fair market value thereof; and

WHEREAS the City of Charlotte, after such fair negotiations, has of this date been unable to acquire properties as hereinafter set out and recognizes that such acquisition is essential to the achievement of the plans and accomplishment of the purpose of the redevelopment law as the same relates thereto; and

WHEREAS it therefore appears that it will be necessary for the City of Charlotte to institute condemnation proceedings under the provisions of the North Carolina Law of Eminent Domain and the exercise of powers thereunder.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina, that the Council approves and hereby orders the institution of condemnation proceedings in its proper corporate name with respect to the following properties:
