ORDINANCE NO. 1489-X

AN ORDINANCE TO AMEND ORDINANCE NO. 1376-X, THE 1983-84 BUDGET ORDINANCE, PROVIDING AN APPROPRIATION FOR EXPANSION OF THE INFLIGHT CATERING FACILITY AT THE AIRPORT.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1. That the sum of \$1,180,000 is hereby estimated to be available from 1980 Air Cargo Revenue Bond Fund No. 42150 for expansion of the inflight catering facility leased to Dobbs House, Inc.

Section 2. That the sum of \$1,180,000 is hereby appropriated to Airport Capital Improvement Account 2073; 562.80 - Air Cargo Development.

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance shall become effective upon its adoption.

ORDINANCE 1491

AN ORDINANCE AMENDING CHAPTER 20, SECTION 86 OF THE CHARLOTTE CITY CODE

WHEREAS, it has been determined, upon the basis of an engineering and traffic investigation, that the speed limit on certain streets of the City of Charlotte, some being a part of the State Highway System, should be established, and

WHEREAS, G.S. 20-141 (speed restrictions) requires adoption of a speed limit ordinance to amend Chapter 20, Section 86(C) of the Charlotte City Code,

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Charlotte,

ORDINANCE 1492

AMENDING CHAPTER 20

AN ORDINANCE AMENDING CHAPTER 20, ENTITLED "TRAFFIC", OF THE CODE OF THE CITY OF CHARLOTTE.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina, that:

Section 1. Chapter 20, Section 86, Subsection (c) shall be amended by repealing and deleting only those city school zone speed limit ordinances in Schedule 10, which Schedule 10 is incorporated by reference in Section 20-86(c) as if fully stated herein, that pertain to the specific city school zone speed limits identified below and those repealed city school zone speed limit ordinances in Schedule 10 shall be superseded by the specific city school zone speed limit ordinances identified below.

Section 2. Schedule 10 referred to in Chapter 20, Section 86, Subsection (c), of the Charlotte City Code be amended by declaring school zone speed limits on the following state highway system streets as described below:



Section 4. Section 2 and Section 3 of this ordinance shall become effective upon adoption by the City Council and after signs are erected giving notice of the school zone, the authorized speed limit, and the days and hours when the lower limit is effective as required by N.C.G.S. Section 20-141.1 and as hereafter amended. Further Section 2 of this ordinance shall not become effective until the Department of Transportation has passed concurring ordinances as required by N.C.G.S. Section 20-141(f) for those school zone speed limits on streets that are part of the state highway system.

Section 5. This ordinance shall become effective upon adoption.
