A JOINT RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHARLOTTE AND THE BOARD OF COMMISSIONERS OF MECKLENBURG COUNTY REGARDING THE ZONING AND SUBDIVISION REGULATIONS OF CERTAIN "BOUNDARY STRIPS" CREATED BY THE ANNEXATION OF THE RAINTREE/PROVIDENCE PLANTATION AREA EFFECTIVE JULY 16, 1984.

WHEREAS, the City of Charlotte annexed the Raintree/Providence Plantation area effective July 16, 1984 and subsequently adopted zoning and subdivision regulations for those areas effective on August 20, 1984.

WHEREAS, in establishing a portion of the exterior boundaries of the Raintree/ Providence Plantation area, certain street rights-of-way were used as a reference (being the right-of-way line for the reference street which was closer to an unincorporated area of Mecklenburg County as of July 16, 1984), the annexation boundary actually being located ten (10) feet away from and parallel to said right-of-way (moving in a direction perpendicular to said right-of-way line and toward the closest unincorporated area of Mecklenburg County as of July 16, 1984), (the area between the center line of the reference street and the annexation boundary hereinafter referred to as "boundary strips"); and

WHEREAS, the City of Charlotte and Mecklenburg County desire to enter into an agreement whereby Mecklenburg County would continue to exercise its zoning and subdivision authority over such boundary strips and whereby the City of Charlotte would not exercise its zoning and subdivision over such boundary strips.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte and the Board of Commissioners of Mecklenburg County that Mecklenburg County shall continue to exercise full zoning and subdivision authority over such boundary strips and the City of Charlotte shall not exercise its zoning and subdivision jurisdiction over such boundary strips.

BE IT FURTHER RESOLVED that the agreement evidenced by this Joint Resolution shall be subject to termination as to all or any portion of such boundary strips by a written resolution formally adopted by either party's governing body and written notice of such action to the other party.





RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHARLOITE, NORTH CAROLINA, APPROVING AMENDMENT NO. 5 TO THE REDEVELOPMENT PLAN FOR THE GRIER HEIGHTS NEIGHBORHOOD STRATEGY AREA

WHEREAS, Title I of the Housing and Community Development Act of 1974 (P.L. 93-383) created a new Community Development Funding Program and amended and extended laws related to housing and urban development and for other purposes; and

WHEREAS, the City of Charlotte has submitted an application in accordance with certain well-defined Federal objectives and has received approval from the United States of America for the execution of a comprehensive Community Development Program to be financed with Community Development Block Grant Funds; and

WHEREAS, one of the Community Development Neighborhood Strategy Area for which such Federal funds have been allocated and the application has been approved is identified as "Grier Heights Neighborhood Strategy Area" encompassing the area generally bounded by Randolph Road and Briar Creek on the west, Monroe Road on the north, Seaboard Coastline Railroad on the east, and on the south by McAlway Road, Beal Street and Billingsley Road, in the City of Charlotte, State of North Carolina (herein called the "Locality"); and

WHEREAS, there has been prepared and approved by the Governing Body a Redevelopment Plan for the Grier Heights Neighborhood Strategy Area dated October, 1975, as amended July, 1976, amended April, 1977, amended April, 1979, amended May 21, 1984, and consisting of 42 pages and 7 exhibits; and

WHEREAS, since the above approvals, it has been desirable and in the public interest to further amend said Redevelopment Plan to revise the Zoning Changes Map and the Land Use Map to reflect a pattern of office land use south of Billingsley Road between Randolph Road and Cascade Circle.

WHEREAS, there has been prepared and referred to the Governing Body of the City of Charlotte for review and approval an amended Redevelopment Plan

for the Area dated August, 1984, and consisting of 42 pages and 7 exhibits; and

3. That it is hereby found and determined that the amended Redevelopment Plan for the Redevelopment Area conforms to the general plan of the Locality.
