NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina at its regularly assembled meeting of <u>February 25</u> 19<u>85</u>, that the Council hereby order the closing of Hamlet Street and <u>a</u> portion of an alleyway in the City of Charlotte, Mecklenburg County, North Carolina.

BE IT FURTHER RESOLVED that a certified copy of this resolution be filed in the Office of the Register of Deeds for Mecklenburg County, North Carolina.



A RESOLUTION AUTHORIZING THE SALE OF THE FACADES AND COLUMNS OF THE FIRST CITIZENS BANK AND TRUST COMPANY TO CHARLOTTE NATIONAL BUILDING.

WHEREAS, pursuant to a June 29, 1984, agreement between the First Citizens Bank and Trust Company at 128 South Tryon Street Charlotte, North Carolina, (hereinafter: "Bank"), and the City of Charlotte (hereinafter: "City"), the Bank gave to the City of Charlotte that portion of the 128 South Tryon Street Bank building consisting of the facade and columns facing South Tryon Street and the facade and columns facing East Fourth Street (hereinafter: "facades and columns"); and

WHEREAS, the purpose of the agreement between the Bank and the City was to preserve those facades and columns for future use in the City of Charlotte, since the facades and columns represent architecture of historic significance to the City of Charlotte; and

WHEREAS, <u>The Charlotte National Building</u> has indicated its desire to use the facades and columns on tax code parcel 24-8 <u>BK 25 Pg 02</u> located at the northwestern corner of Third Street and Caldwell Street; and

WHEREAS, City of Charlotte Charter § 9.21, "Personal property", authorizes the City of Charlotte to sell personal property belonging to the City at private sale and authorizes the Mayor to make title to the purchase of any personal property so sold; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte that the Mayor of the City of Charlotte is authorized to execute an agreement with The Charlotte National Building in respect to the facades and columns and is

authorized to execute a bill of sale of the Bank's facades and columns now owned by the City to <u>The Charlotte National Bldg.</u> if the following conditions are met: 455

1. The Charlotte-Mecklenburg Historic Properties Commission ("Commission") has received and approved any designs and received any other information requested by the Commission.

3. <u>Charlotte National Bldg</u> and the City shall execute an agreement that the facades and columns shall be used only in accordance with the design plan approved by the Commission and that the facades and columns shall be used and the construction completed no later than <u>December 31</u>, 198<u>6</u>.
