WHEREAS, the City of Charlotte Community Development Department has filed a Petition to close Mill Road, Biddle Street, Sparrow Street and an Unnamed Street in the City of Charlotte, Mecklenburg County, North Carolina; and

WHEREAS, Mill Road, Biddle Street, Sparrow Street and an Unnamed Street petitioned to be closed lie within the limits of the Five Points Community Development Area as shown on maps marked Exhibit "A" and through Exhibit "D", and are more particularly described by metes and bounds in a document marked Exhibit "E", all of which are available for inspection in the Office of the City Clerk, City Hall, Charlotte, North Carolina.
