AN ORDINANCE TO AMEND ORDINANCE NO. 2198-X, THE 1987-88 BUDGET ORDINANCE, PROVIDING AN APPROPRIATION FOR A PORTION OF THE DESIGN DEVELOPMENT PHASE OF DISCOVERY PLACE PHASE II.

ORDINANCE 2263

AN ORDINANCE AMENDING CHAPTER 14, SECTION 131 OF THE CHARLOTTE CITY CODE

WHEREAS, on May 14, 1984, the Charlotte City Council approved a policy to provide for a 25 mile per hour speed limit on non-thoroughfare residential streets; and

WHEREAS, the residents of certain streets have submitted a petition signed by at least 75 percent of the residents of the streets affected; and

WHEREAS, it has been determined, upon the basis of an engineering and traffic investigation, that a lowered speed limit on certain streets of the City of Charlotte is not inappropriate; and

WHEREAS, G. S. 20-141 (speed restrictions) requires adoption of a speed limit ordinance to amend Chapter 14, Section 131(c) of the Charlotte City Code,

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Charlotte,

SECTION 1: That Schedule X referred to in Chapter 14-131(c) of the Charlotte City Code be amended by declaring speed limits on the following City System streets as described below:



AN ORDINANCE TO AMEND ORDINANCE NO. 2198-X, THE 1987-88 BUDGET ORDINANCE, APPROPRIATING AIRPORT FUNDS FOR AIR CARGO FACILITIES AND ESTABLISHING A PERMANENT SOURCE OF FUNDS FOR THE PIEDMONT AIR CARGO/CATERING FACILITY

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina:

Section 1. That the sum of \$3,725,000 is hereby estimated to be available from the Airport Pre-DBO Fund Balance.

Section 3. That the sum of \$3,950,000 previously advanced from the unappropriated fund balance of the Airport Fund is hereby the permanent source of funds for the Piedmont Air Cargo/Catering facility

AN ORDINANCE TO AMEND ORDINANCE NO. 2198-X, THE 1987-88 BUDGET ORDINANCE, APPROPRIATING A GRANT AWARD TO THE VICTIM ASSISTANCE PROGRAM.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina:

Section 1. That the sum of \$104,004 is hereby available from the North Carolina Department of Crime Control and Public Safety to provide funds to expand the existing Victim Assistance Program, and is hereby appropriated to the General Fund Account 0101.530.88. It is anticipated that this project may extend beyond the period of the 1987-88 Budget ordinance and will remain in effect for the duration of the grant.

Section 2. Pursuant to standard procedures which have governed the financial arrangements between the City and the Victim Assistance Program, a \$15,000 advance is hereby authorized from anticipated grant revenues from the North Carolina Department of Crime Control and Public Safety for the provision of sufficient funds with which to begin the program.

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance shall become effective upon its adoption.

ORDINANCE NO. 2266

AMENDING CHAPTER 10

AN ORDINANCE AMENDING CHAPTER 10 OF THE CITY CODE OF THE CITY OF CHARLOTTE TO ADD A NEW DIVISION TO ARTICLE II ENTITLED, "RECYCLABLE MATERIAL".

BE IT ORDAINED by the City Council of the City of Charlotte that:

Section 1. Chapter 10, Article II, § 10-16 shall be amended by adding a new definition to read as follows:

"Recyclable materials mean beer and soft drink cans, newspaper, plastic soft drink bottles and glass containers."

Sec. 2. Chapter 10, Article II shall further be amended by the addition of a new Division 8, entitled "Recyclable materials" to read as follows:

"DIVISION 8. RECYCLABLE MATERIALS.

Sec. 10-130. Collection by unauthorized persons prohibited.

Whenever an owner or occupant of property places recyclable materials at curbside for collection, they are deemed to be abandoned by such person, and become the property of the City or its authorized agent. From the time of placement of these materials at curbside for collection, it shall be unlawful for any person, firm or corporation not authorized by the City to collect or pick up or cause to be collected or picked up, any such materials.

Sec. 10-131. Violation and penalty.

Any person, firm or corporation that violates § 10-130 shall, upon conviction thereof, be fined not more than five hundred dollars (\$500.00).

A citation of twenty-five dollars (\$25.00) may be issued as provided for in § 10-23(1) and as described procedurally in § 10-24."

Sec. 3. This ordinance shall become effective upon adoption.

AMENDING CHAPTER 13

ORDINANCE 2267

AN ORDINANCE AMENDING CHAPTER 13 OF THE CITY CODE TO PROVIDE A REDUCTION IN THE PRIVILEGE TAX ON MOTOR VEHICLES FOR CERTAIN ELDERLY RESIDENTS.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina, that:

Section 1. Section 13-36 of Chapter 13 of the City Code shall be amended by changing the existing subsection "(b)" to "(c)", and adding a new subsection "(b)" to read as follows:

"(b) Exception for the Elderly. Any resident who is 65 years or older prior to January 1st of each year may qualify, upon application, for a \$10.00 reduction in the annual motor vehicle privilege license tax; provided, however, their disposable income does not exceed \$11,000.00. If the vehicle is in both husband and wife's name, their combined disposable income must not exceed \$11,000.00. For the purpose of this section, "disposable income" shall mean their adjusted gross income as defined for North Carolina State Income Tax purposes in G. S. 105-141.3, plus all other moneys received from every source other than gifts or inheritances received from a spouse, lineal ancestors, or lineal descendants."

Sec. 2. This ordinance shall become effective upon adoption.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina:


Section 1. That the sum of \$395,000 is hereby estimated to be available from the Water and Sewer Debt Service Fund unappropriated fund balance;
