ORDINANCE 2289

AN ORDINANCE AMENDING CHAPTER 14, SECTION 131 OF THE CHARLOTTE CITY CODE

WHEREAS, on May 14, 1984, the Charlotte City Council approved a policy to provide for a 25 mile per hour speed limit on non-thoroughfare residential streets; and

WHEREAS, the residents of certain streets have submitted a petition signed by at least 75 percent of the residents of the streets affected; and

WHEREAS, it has been determined, upon the basis of an engineering and traffic investigation, that a lowered speed limit on certain streets of the City of Charlotte is not inappropriate; and

WHEREAS, G. S. 20-141 (speed restrictions) requires adoption of a speed limit ordinance to amend Chapter 14, Section 131(c) of the Charlotte City Code,

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Charlotte,

SECTION 1: That Schedule X referred to in Chapter 14-131(c) of the Charlotte City Code be amended by declaring speed limits on the following City System streets as described below:

| <u>STREET AND DESCRIPTION</u> | <u>SPEED LIMIT</u> |
|---|--------------------|
| 1. Birchcrest Drive between Darbrook Drive and Dunnaire Drive. | 25 |
| 2. Carmel Station Avenue between Carmel Hills Drive and cul-de-sac. | 25 |
| 3. Londonderry Road between Tyvola Road and Emerywood Drive. | 25 |

SECTION 2: Section 1 shall become effective upon adoption and after signs are erected giving notice of the speed limits, as required by N.C.G.S. Section 20-141.

AN ORDINANCE TO AMEND ORDINANCE NO. 2198-X, THE 1987-88 BUDGET ORDINANCE, TRANSFERRING FUNDS FROM THE WATER AND SEWER UNAPPROPRIATED FUND BALANCE FOR CONSTRUCTION OF SEWER FACILITIES IN THE PROVIDENCE ROAD/PLANTATION ROAD AREA.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1. That the sum of \$1,260,000 is hereby available from the unappropriated Water and Sewer Operating Fund balance;

AN ORDINANCE TO AMEND ORDINANCE NO. 2198-X, THE 1987-88 BUDGET ORDINANCE, ADVANCING FUNDS FROM THE UNAPPROPRIATED WATER AND SEWER OPERATING FUND BALANCE FOR CONSTRUCTION OF WATER AND SEWER SYSTEMS IN ANNEXATION AREAS.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1. That the sum of \$1,000,000 is hereby available from the following sources:

- 1986 Sewer Bonds - \$250,000
- 1986 Water Bonds - \$750,000

for construction of water and sewer systems in annexation areas.

Section 2. That the sum of \$1,000,000 is hereby appropriated to the following Water and Sewer Capital Improvement Fund control accounts:

- 2071;633.40 - 1986-87 Annexation Sewer Collection System - \$250,000
- 2071;635.51 - 1986-87 Annexation Water Distribution System - \$750,000

Section 3: That the Finance Director or his designee is hereby authorized to transfer funds from the unappropriated Water and Sewer Operating Fund Balance to the Water and Sewer Capital Improvement Fund accounts 2071;633.40 and 2071;635.51 until 1986 Water Bonds and 1986 Sewer Bonds are issued. Upon issuance of these bonds, the funds will be repaid to the Water and Sewer Operating Fund Balance.

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. This ordinance shall become effective upon its adoption.

AMENDING CHAPTER 19

ORDINANCE 2294

AN ORDINANCE AMENDING CHAPTER 19, ARTICLE IV, "NUMBERING OF BUILDINGS" TO TRANSFER RESPONSIBILITY FOR ASSIGNMENT OF STREET ADDRESSES FROM CITY ENGINEERING DEPARTMENT TO COUNTY, AND TO TRANSFER RESPONSIBILITY FOR ENFORCEMENT TO FIRE DEPARTMENT IN ACCORDANCE WITH INTERLOCAL AGREEMENT, AS AMENDED.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina that:

Section 1. Section 19-97 of the City Code shall be amended by the deletion of the word "city" in the first and fourth sentences, and substituting in lieu thereof of the word "county".

Section 2. Section 19-98, subsection (7) shall be amended by the deletion of the word "city" in the last sentence, and substituting in lieu thereof the word "county".

Section 3. Section 19-99 shall be amended by the deletion of the word "city" in the second sentence, and substituting in lieu thereof the word "county".

Section 4. Section 19-101 shall be deleted in its entirety, and the following substituted in its place:

"Section 19-101. Enforcement - Penalties.

A violation of this ordinance shall also be a violation of the City's Fire Code. Fire inspectors and fire officers of the rank of captain or above shall be responsible for the enforcement of this ordinance, and a violation thereof shall be subject to the penalties provided for in Sections 8-11 and 8-12."

Section 5. This ordinance shall become effective upon adoption.
