AN ORDINANCE TO AMEND ORDINANCE NO. 2198-X, THE 1987-88 BUDGET ORDINANCE, PROVIDING AN APPROPRIATION TO CONTRACT WITH NORTH CAROLINA PERFORMING ARTS CENTER, INC. FOR SERVICES ASSOCIATED WITH THE CONSTRUCTION OF THE PERFORMING ARTS CENTER.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

AN ORDINANCE TO AMEND ORDINANCE NO. 2198-X, THE 1987-88 BUDGET ORDINANCE, APPROPRIATING FUNDS TO THE ENGINEERING DEPARTMENT BUDGET FOR REAL ESTATE SERVICES FOR THE AIRPORT DEPARTMENT.

AN ORDINANCE TO AMEND ORDINANCE NO. 2198-X, THE 1987-88 BUDGET ORDINANCE, PROVIDING SUPPLEMENTAL APPROPRIATIONS FOR TWO AIRPORT CAPITAL PROJECTS.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

ORDINANCE NO. 2356-X

AN ORDINANCE TO AMEND ORDINANCE NO. 2198-X, THE 1987-88 BUDGET ORDINANCE, PROVIDING SUPPLEMENTAL APPROPRIATIONS FOR IDLEWILD ROAD WIDENING AND BEATTIES FORD ROAD WIDENING TO AWARD DESIGN CONTRACTS.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1. That the sum of \$1,030,000 is hereby available from 1987 Street Improvement Bonds to award design contracts with Rummell, Klepper and Kahl for Idlewild Road and Ralph Whitehead and Associates for Beatties Ford Road.

Section 2. That the sum of \$1,030,000 is hereby appropriated to the following General Capital Improvement Fund (2010) capital project accounts:
