A RESOLUTION AUTHORIZING THE SUBMISSION OF AN APPLICATION REQUESTING ASSISTANCE FROM THE NORTH CAROLINA CLEAN WATER REVOLVING LOAN AND GRANT PROGRAM FOR THE CONSTRUCTION OF WASTEWATER TREATMENT WORKS, WASTEWATER COLLECTION SYSTEMS, AND WATER SUPPLY SYSTEMS

WHEREAS, The North Carolina Clean Water Revolving Loan and Grant Act of 1987 has authorized the making of grants and loans to aid eligible units of government in financing the cost of construction of wastewater treatment works, wastewater collection systems, and water supply systems; and,

WHEREAS, the City of Charlotte has need for and intends to construct various water and sewer facilities which do qualify for state revolving loan assistance; and,

Wendell White is hereby authorized and directed to furnish such information as the appropriate State agency may request in connection with such application or the projects; to make the assurances as may be required; and to execute such other documents as may be requested in connection with the application, and loan offer or award;

That the City of Charlotte has substantially complied to will substantially comply with all Federal, State and local laws, rules, regulations, and ordinances applicable to the projects; and hereby authorizes the above designated representative to execute an affidavit so stating.

That the City of Charlotte agrees to adopt and place into effect on or before completion of the projects a schedule of fees and charges which will provide adequate funds for proper operation, maintenance and administration of the projects, and repayment of all principal and interest on awarded loans.
