

Beginning at an old P.K. nail on the intersection of the easterly right-of-way margin of Westbury Road and the southerly right-ofway of Robin Road, said point being the northeasterly corner of Lot 1 of Providence Park Subdivision as recorded in Map Book 3 Page 105, property of Robert Green as recorded in Deed Book 5789 Page 926; thence with the projection of the easterly right-of-way of Westbury Road N 36-26-09 E, 16.46 feet to a new iron in the northerly right-of-way of Robin Road, said point being S 28-10-00 E, 33.35 feet from the common corner of Debra A. Hassen, recorded in Deed Book 5094 Page 546, and Walter Guy Lineberger, recorded in Deed Book 1727 Page 119; thence with the northerly Lineberger S 28-10-00 E, 66.65 feet to an old iron reset at the common corner of Lineberger and Robert G. MacMartin and wife Elizabeth A. MacMartin, recorded in Deed Book 5218 Page 287; thence continuing with the MacMartin line and along the northerly right-of-way of Robin Road S 28-01-00 E, 100.14 feet to an old iron (angle point in Robin Road right-of-way as shown on Map Book 11 Page 177); thence S 37-05-10 W, 12.94 feet from an old iron in the southerly right-of-way of Robin Road right-of-way as shown on Map Book 5789 Page 926, also being the easterly line of Lot 1 of Providence Park Subdivision, recorded in Map Book 3 Page 105, N 29-09-26 W, 165.17 feet to the beginning containing 2,226 square feet or 0.051 Acres.

RESOLUTION DIRECTING THAT STORM DRAINAGE IMPROVEMENTS BE MADE ON NORTHCLIFF DRIVE IN THE CITY OF CHARLOTTE, MECKLENBURG COUNTY, NORTH CAROLINA

WHEREAS, Gary L. Brown has filed a Petition to make storm drainage improvements on Northcliff Drive in the City of Charlotte, North Carolina; and

WHEREAS, the storm drainage improvements shall be made on private property at 1832 and 1838 Northcliff Drive as shown on a map marked "Exhibit A" which is available for inspection in the office of the City Clerk, City Hall, Charlotte, North Carolina; and

WHEREAS, one-half of the cost of the storm drainage improvements construction in accordance with City standards, of a character, size, type and material to be determined by the City and including grading or regrading, exclusive of the cost incurred in maintained street rights-of-way and the share of railroads (if any) and the State of North Carolina (if any) be assessed upon the involved lots and parcels of land as authorized by N.C.G.S. Article 10, Chapter 160A, City Charter Section 7.101 et seq, and the Storm Drainage Repair Policy, and listed on the limited petition marked "Exhibit B" which is available for inspection in the office of the City Clerk, City Hall, Charlotte, North Carolina; and

WHEREAS, the final assessments, based on the actual total cost of constructing the improvements or the cost estimated by the City Engineer at the time of City Council approval, whichever is less, and published by the Mecklenburg County Tax Collector, may be paid without interest within 30 days of the publication, or in ten annual installments accruing 8% interest on the unpaid balance, due and payable each year on the date property taxes are due; and

WHEREAS, all involved property owners subject to assessment have signed a petition requesting that storm drainage repairs be made and one-half of the private property cost be assessed on their lots and parcels of land, precluding the need for a public hearing.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina, at its regularly assembled meeting of April 23, 1990, that the Council hereby orders the making of storm drainage improvements on Northcliff Drive in the City of Charlotte, North Carolina.

BE IT FURTHER RESOLVED that a certified copy of the Resolution be filed in the Office of the Register of Deeds for Mecklenburg County, North Carolina.



RESOLUTION DIRECTING THAT STORM DRAINAGE IMPROVEMENTS BE MADE ON DAWNSHIRE AVENUE IN THE CITY OF CHARLOTTE, MECKLENBURG COUNTY, NORTH CAROLINA

WHEREAS, James H. Woods has filed a Petition to make storm drainage improvements on Dawnshire Avenue in the City of Charlotte, North Carolina; and

WHEREAS, the storm drainage improvements shall be made on private property at 3101 Dawnshire Avenue as shown on a map marked "Exhibit A" which is available for inspection in the office of the City Clerk, City Hall, Charlotte, North Carolina; and

WHEREAS, one-half of the cost of the storm drainage improvements constructed in accordance with City standards, of a character, size, type and material to be determined by the City and including grading or regrading, exclusive of the cost incurred in maintained street rights-of-way and the share of railroads (if any) and the State of North Carolina (if any) be assessed upon the involved lots and parcels of land as authorized by N.C.G.S. Article 16, Chapter 160A, City Charter Section 7.101 et seq, and the Storm Drainage Repair Policy, and listed on the limited petition marked "Exhibit B" which is available for inspection in the office of the City Clerk, City Hall. Charlotte, North Carolina; and

WHEREAS, the final assessments, based on the actual total cost of constructing the improvements or the cost estimated by the City Engineer at the time of City Council approval, whichever is less, and published by the Mecklenburg County Tax Collector, may be paid without interest within 30 days of the publication, or in ten annual installments accruing 8% interest on the unpaid balance, due and payable each year on the date property taxes are due; and

WHEREAS, all involved property owners subject to assessment have signed a petition requesting that storm drainage repairs be made and one-half of the private property cost be assessed on their lots and parcels of land, precluding the need for a public hearing.

NOW, THEREFORE. BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina, at its regularly assembled meeting of April 23, 1990, that the Council hereby orders the making of storm drainage improvements on Dawnshire Avenue in the City of Charlotte, North Carolina.


