

ORDINANCE NO. 3212

AN ORDINANCE AMENDING SECTION 11-29 OF THE CITY CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE THAT;

SECTION 11-29 IS AMENDED TO READ AS FOLLOWS:

COMPLAINTS OR ORDERS ISSUED BY THE DIRECTOR SHALL BE SERVED UPON PERSONS EITHER PERSONALLY OR BY REGISTERED OR CERTIFIED MAIL. IF THE IDENTITIES OF ANY OWNERS OR THE WHEREABOUTS OF PERSONS ARE UNKNOWN AND CANNOT BE ASCERTAINED BY THE DIRECTOR IN THE EXERCISE OF REASONABLE DILIGENCE, OR, IF THE OWNERS ARE KNOWN BUT HAVE REFUSED TO ACCEPT SERVICE BY REGISTERED OR CERTIFIED MAIL, AND THE DIRECTOR MAKES AN AFFIDAVIT TO THAT EFFECT, THEN THE SERVING OF THE COMPLAINT OR ORDER UPON THE OWNERS OR OTHER PERSONS MAY BE MADE BY PUBLICATION IN A NEWSPAPER HAVING GENERAL CIRCULATION IN THE CITY AT LEAST ONCE NO LATER THAN THE TIME AT WHICH PERSONAL SERVICE WOULD BE REQUIRED UNDER THE PROVISIONS OF THIS CHAPTER. WHEN SERVICE IS MADE BY PUBLICATION, A NOTICE OF THE PENDING PROCEEDINGS SHALL BE POSTED IN A CONSPICUOUS PLACE ON THE PREMISES THEREBY AFFECTED.

ORDINANCE NO. 3214

AMENDING CHAPTER 10

AN ORDINANCE AMENDING CHAPTER 10, ENTITLED "HEALTH AND SANITATION", OF THE CITY CODE OF THE CITY OF CHARLOTTE.

BE IT ORDAINED by the City Council of the City of Charlotte, NC, that:

Section 1. Chapter 10 of the City Code of the City of Charlotte shall be amended as follows:

1. Amend § 10-54, "Reserved", by adding a new § 10-54 entitled, "Central Business District and Tryon Street Mall", to read as follows:

"(a) For purposes of this section, 'central business district' ('CBD') refers to the area included between Graham Street, West 11th Street, McDowell Street, and Morehead Street except for the geographic area described in the following paragraph as the 'Tryon Street Mall'.

"(b) 'Tryon Street Mall' ('Mall') refers to the area of Tryon Street beginning at Stonewall Street and extending to Eighth (8th) Street, including the blocks designated as the 100 blocks of East and West Trade Street, and includes both sides of Tryon Street and Trade Street as described above.

"(c) Collection in the CBD and the Mall shall be limited to a maximum of eight (8) thirty-two-gallon refuse containers or the equivalent placed in securely tied two-ply plastic bags. All cardboard boxes and cartons must be placed at curbside. Containers, cardboard boxes, cartons, or bags of garbage or trash shall be placed at curbside in the CBD between 9:00 a.m. and 10:00 a.m. Monday through Friday and shall be removed from the sidewalks within one (1) hour after collection. The same (i.e. containers, cardboard boxes, etc.) shall be placed at curbside on the Mall only between 8:30 a.m. and 9:00 a.m. Monday through Friday and shall be removed from the sidewalks by 10:30 a.m.

"(d) Penalty. A citation in the amount of twenty-five (\$25.00) dollars will be issued to any person in violation of this section."

Section 2. This ordinance shall become effective upon adoption.
