AN ORDINANCE AMENDING CHAPTER 3 OF THE CITY CODE ENTITLED "ANIMALS" AS TO LICENSE FEES AND THE PROPATION OF LICENSE FEES.

Section 1. Section 3-31(b) shall be amended by deleting the words and figures "twenty dollars (\$20.00)" and "five dollars (\$5.00)",

BE IT ORDAINED by the City Council of the City of Charlotte that:

and substituting in lieu thereof the words and figures "twenty-five

dollars (\$25.00)" and "seven dollars and fifty cents (\$7.50)".

Sec. 2. Section 3-34(b) shall be amended by deleting the words and figures "twenty dollars (\$20.00) and "five dollars (\$5.00)", and substituting in lieu thereof the words and figures "twenty-five dollars (\$25.00)", and "seven dollars and fifty cents (\$7.50)". Subsection (b) shall be also be amended by adding a new sentence at the end to read as follows:

"The license fee for equines shall be ten dollars (\$10.00)".

Subsection shall be further amended by deleting the second paragraph beginning with the word "If and ending with the word "sterilized.", and substituting in lieu thereof the following paragraph:

"New owners of animals requiring a license tag
shall pay the full fee if purchased within the
period July through December. After January 1,
the license fee may be prorated depending on the
month the animal was acquired. Satisfactory proof

> must be furnished to the department showing the date the animal was acquired before proration of the license will apply. A copy of the prorated schedule of fees shall be displayed conspicuously in the department as well as in the Office of the Revenue Division of the Finance Department."
