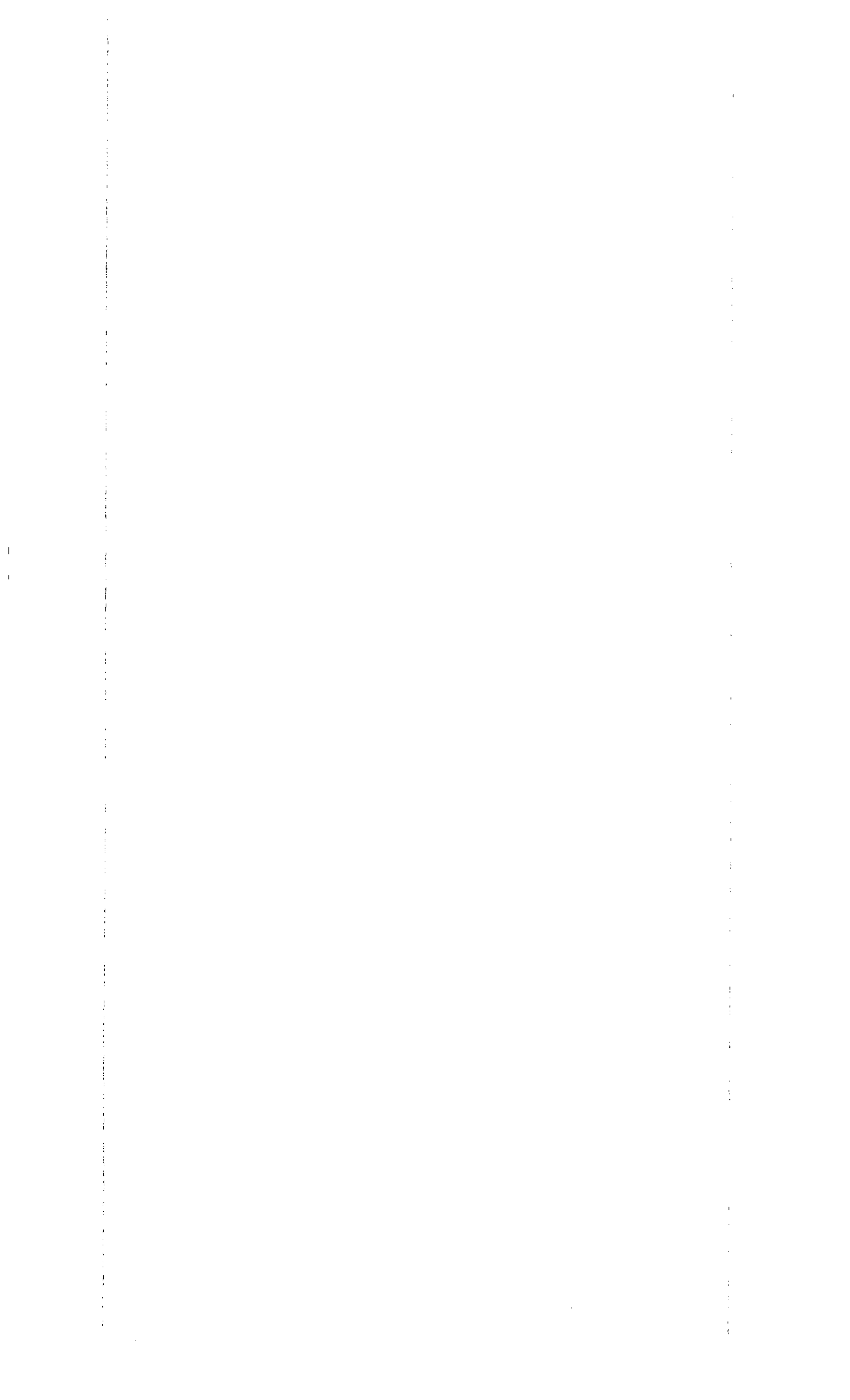

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHARLOTTE AMENDING
THE FIVE-YEAR CAPITAL IMPROVEMENT PROGRAM FOR FY1992-96.

WHEREAS, the City of Charlotte has adopted a five-year program as a plan for needed capital facilities during fiscal years 1992-96; and

WHEREAS, a need has been identified to appropriate funds in fiscal year 1992 originally scheduled for construction in fiscal year 1993 of a Parallel Outfall Along Paw Creek; and

WHEREAS, funds are available from 1990 Sewer Bonds for the construction of a Parallel Outfall Along Paw Creek; and

WHEREAS, this project concurs with the intent of the Capital Improvement Program to balance the City's future physical development with its long range financial capacity.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, in regular session duly assembled that it does hereby formally amend the Capital Improvement Program for FY1992-96 to include the appropriation of funds in FY1992 scheduled for fiscal year 1993 for the aforementioned utility project.

STATE OF NORTH CAROLINA - COUNTY OF MECKLENBURG
RESOLUTION CALLING FOR A PUBLIC HEARING
ON AMENDMENT NO. 5 TO THE REDEVELOPMENT PLAN
FOR BROOKLYN URBAN RENEWAL AREA - SECTION NO. 3

WHEREAS, under the authority of Article 22 of Chapter 160A of the General Statutes of North Carolina and particularly Section 160A-513 of the General Statutes, the City of Charlotte is preparing an amendment to the Redevelopment Plan for the Brooklyn Urban Renewal Area, Section No. 3, Charlotte, North Carolina; and

WHEREAS, the proposed Amendment to the Redevelopment Plan will not substantially change the plan and will be submitted to the Charlotte-Mecklenburg Planning Commission for their review and comments at their Planning Committee's January 28, 1992 meeting; and

WHEREAS, the boundaries for the Brooklyn Urban Renewal Area, Section No. 3, are generally South McDowell Street, East Fourth Street, Interstate 277 and Independence Boulevard; with metes and bounds descriptions specified in the Redevelopment Plan; and

WHEREAS, the Redevelopment Plan for the Brooklyn Urban Renewal Area, Section No. 3, with such maps, plans and other documents which are part of the proposal, are available for public inspection at the office of the Community Development Department of the City of Charlotte, 600 East Fourth Street, Charlotte, North Carolina, between the hours of 8:00 a.m. to 5:00 p.m., Monday through Friday.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

1. That on Monday, March 23, 1992, at 7:00 p.m. the City Council shall hold a public hearing prior to amending the Redevelopment Plan for the Brooklyn Urban Renewal Area, Section No. 3.
2. That this Resolution shall be published at least once a week for two consecutive weeks in the Charlotte Observer, a newspaper of general circulation in the City of Charlotte, the first publication to be not less than fifteen (15) days prior to March 23, 1992.


WHEREAS, the City of Charlotte desires to continue functional consolidation in order to improve the accountability and efficiency of local government; and

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHARLOTTE
RECOMMENDING ACCELERATION OF THE US 74 FREEWAY/EXPRESSWAY/
HOV FACILITY PROJECT (U-209) BY THE NORTH CAROLINA DEPARTMENT
OF TRANSPORTATION

WHEREAS, the conversion of Independence Boulevard into a freeway was recommended in the 1960 Thoroughfare Plan; and

WHEREAS, completion of US 74 improvements is the City's highest priority transportation project; and

WHEREAS, the North Carolina Department of Transportation agreed in 1985 to complete US 74 improvements between Brookshire Freeway and Albemarle Road entirely at State expense in exchange for the City's assumption of NC 51 widening; and

WHEREAS, the City completed the \$14.9 million NC 51 widening project in 1991 at no cost to the State; and

WHEREAS, the City obtained a \$13.2 million grant from the Federal Transit Administration to build a busway/High Occupancy Vehicle lane in the median of a reconstructed US 74; and

WHEREAS, the Federal Transit Administration is concerned that schedule delays on the US 74 project could result in cost increases to the busway project; and

WHEREAS, the 1992-98 North Carolina Transportation Improvement Program shows that construction on the Brookshire-to-Briar Creek and Eastway-to-Albemarle segments of the US 74 project will not begin until after 1998 although plans for both sections will be complete in 1992; and

WHEREAS, a five-year period, at a minimum, in which there is no construction activity on the US 74 project is unacceptable given a current daily volume of over 90,000 vehicles per day on this roadway; and

WHEREAS, the Intermodal Surface Transportation Efficiency Act of 1991 increases the level of Federal highway funds to be distributed to the State of North Carolina.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, in its regular session duly assembled, strongly recommends that the North Carolina Department of Transportation accelerate the schedule for the remaining two segments of the US 74 Freeway/Expressway/High Occupancy Vehicle Facility project (Project Numbers U209-C and U209-F) in order to comply with the spirit of the 1985 City/State transportation agreement.
