# RESOLUTION ENDORSING

#### ECONOMIC DEVELOPMENT FINANCING

WHEREAS: On November 2, 1993, North Carolina voters will be able to choose whether to amend the North Carolina Constitution to allow local governments to issue Economic Development Financing Bonds, and;
