BE IT ORDAINED by the City Council of the City of Charlotte that:

• Chapter 7, Section 2 (a) of the City Code is hereby amended by deleting the present language of:

"The director of parks and recreation department ..."

and substituting in lieu thereof the following:

"The City Engineer ..."

• Chapter 7, Section 2(c) is hereby amended by deleting the present language of:

"City Grounds. The city manager shall lay out one section to be known as city grounds and held for those unable to pay for burial space."

and substituting in lieu thereof the following:

"City Grounds. The city manager shall layout one section to be known as city grounds and held for those unable to pay for burial space. A two hundred (\$200) dollar fee will be charged to the indigent burial fund for each grave space. The opening/closing of the grave will be at current opening/closing rate."

- Chapter 7, Section 3(c) is hereby amended by deleting the present language of:
- (c) "Loss of deed. In case of the loss or destruction of a deed issued as provided in paragraph (b) of this section the city manager, or the officer of the city designated by him, on proof satisfactory to him of such loss or destruction, shall have issued, a new deed executed as hereinbefore set out to the original holder or to any transferee of him upon payment of five dollars (\$5.00)."

and substituting in lieu thereof the following:

(c)"Loss of deed. In case of the loss or destruction of a deed issued as provided in paragraph (b) of this section the city manager, or the officer of the city designated by him, on proof satisfactory to him of such loss or destruction, shall have issued, a duplicate deed

executed as hereinbefore set out to the original holder or to any transferee of him upon payment of fifty dollars (\$50). This includes issue of transfer deed."

• Chapter 7, Section 6(b) Perpetual Care Fund is hereby amended by deleting the present language of:

"Established. A fund known as the perpetual care fund, shall be established for the purpose of perpetually caring for and beautifying the city cemeteries described in section 7-2(a) of this chapter. The city treasurer may accept gifts and bequests to the fund upon such terms as the donor may prescribe. In addition, there shall be set aside a twenty-five (25) per cent surcharge on all monuments and marker foundation and setting charges, and such revenues from the sale of lots as are not needed in any fiscal year to offset the cemeteries' operating expenditures during that fiscal year."

and substituting in lieu thereof the following:

"Established. A fund known as the perpetual care fund, shall be established for the purpose of perpetually caring for and beautifying the city cemeteries described in section 7-2(a) of this chapter. The city treasurer may accept gifts and bequests to the fund upon such terms as the donor may prescribe."

• Chapter 7, Section 9. Extension of Credit is hereby amended by deleting the present language of:

"In the following sections of this chapter whenever the term "payment" is used, payment shall be deemed satisfied either by the payment of cash by the purchaser or an extension of credit to a funeral director. All payments for lots, grave openings, and other charges shall be in cash..."

and substituting in lieu thereof the following:

"In the following sections of this chapter whenever the term 'payment' is used, payment shall be deemed satisfied either by payment with check, money order, or cashier check by the purchaser or an extension of credit to a funeral director. All payments for lots, grave openings, and other charges shall be made by check, money order, cashier check, or any other method of payment subsequently approved by the Finance Director."

• Chapter 7, Section 12. Monuments and markers is hereby amended by deleting the present language of:

"All monument and markers to be placed in city-owned cemeteries must conform to the requirements as set forth in that certain pamphlet entitled "Cemetery Rules and Regulations, City

of Charlotte," dated June 1, 1975. All foundations for markers and monuments will be constructed by city forces and all markers will be set by city forces."

and substituting in lieu thereof the following:

"All monument and markers to be placed in city-owned cemeteries must conform to the requirements as set forth in that certain pamphlet entitled "Cemetery Rules and Regulations, City of Charlotte," dated July 1, 1994. All foundations for markers and monuments will be constructed by city forces and all markers will be set by city forces."

- Chapter 7, Section 13 (a). Charges is hereby amended by deleting the present language of:
- (a) "Interments, disinterments. Charges for interments and disinterments in city cemeteries shall be as follows:
 - (1) Charges for interments and disinterments shall be based on actual costs. For the purpose of this subsection, "actual costs" shall consist of charges for labor and the use of equipment. Records substantiating such actual costs shall be kept by the supervisor of the cemeteries division.
 - (2) Burial of cremains or interment in a mausoleum shall be fifty (50) percent of the fee charged for grave burials as determined in paragraph (1)(a) of this section.
 - (3) An additional fifty dollars (\$50.00) for perpetual care shall be charged for burial with a wooden box.
 - (4) Funerals starting after 4:00 p.m. on weekdays, or all day Saturday or city holidays shall be charged an additional fifty (50) percent for interments. No interments or disinterments shall be accomplished on Sunday."
- (b) "Purchase of grave space: The prices for purchases of grave space in the city cemeteries shall be as follows:
- (1) Elmwood and Evergreen Cemeteries: The price for grave space in Elmwood and Evergreen Cemeteries shall be seventy-five (75) percent of the local prevailing market price.
 - (2) Oaklawn and Pinewood Cemeteries. The price for grave space in Oaklawn and Pinewood Cemeteries shall be sixty-five (65) percent of the fee charged for Elmwood and Evergreen Cemeteries.

For the purpose of this paragraph (b) of this section, "local prevailing market price" shall

be the average fee charged by nonchurch-related, commercial cemeteries in the city as of July first of each year, as to their lots located in the city."

- (c) "Monuments and markers: The fees for monuments and markers in the city cemeteries shall be as follows:
- (1) The fee charged for monument and marker foundations, markers and/or vase settings shall be based on actual costs. For the purpose of this paragraph © of this section, "actual costs" shall consist of charges for labor, use of equipment and materials.
- (2) An additional twenty-five (25) percent charge for perpetual care shall be made for all foundations, markers and vase settings.

Any charge based on actual costs shall be reviewed and established by the city manager within sixty (60) days following July first of each year. A schedule of all cemetery charges shall be available for inspection in the offices of the supervisor of the cemeteries division and the city clerk."

and substituting in lieu thereof the following:

- (a) "Interments, disinterments. Charges for interments and disinterments in city cemeteries shall be as follows:
 - (1) A fee to be determined by the City Engineer or the Cemeteries Supervisor for perpetual care shall be charged for burial with a wooden box.
 - (2) An additional fifty (50) percent fee shall be added to the base fee for funerals entering the cemetery after 3:30 p.m. on weekdays, all day on Saturdays, and on City holidays. No interments or disinterments shall be scheduled on Sunday or after 4:00 p.m. on Saturday."
- (b) "Purchase of grave space: The prices for purchases of grave space in the city cemeteries shall be as follows:
 - (1) The price for grave space in the city cemeteries shall be determined by the City Engineer upon review of prices in private cemeteries in the city limits of the City of Charlotte and review of cemetery budget needs at the end of fiscal year.
- (c)"Monuments and markers: The fees for monuments and markers in the city cemeteries shall be as follows:
 - (1) The fee charged for monument and marker foundation, markers and/or vase settings shall be based on budget needs at the end of fiscal year.
