BE IT ORDAINED, by the City Council of the City of Charlotte;


Section 1. That the sum of \$250,000 is hereby estimated to be available from

AMENDING CHAPTER 14

**ORDINANCE AMENDING CHAPTER 14 OF THE CHARLOTTE CITY CODE
ENTITLED "MOTOR VEHICLES AND TRAFFIC"**

BE IT ORDAINED, by the City Council of the City of Charlotte, North Carolina that:

Section 1. Section 14-97(a) of Article III, entitled "Bicycles," of Chapter 14, "Motor Vehicles and Traffic," of the Charlotte City Code is amended by adding the following sentence at the end of the subsection:

"Provided, police officers acting in the discharge of their official duties are permitted to operate bicycles upon all of the public sidewalks in the City, including those sidewalks located within the congested business district."

Section 2. This ordinance shall take effect upon adoption.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;


Section 1. That the sum of \$450,000 is available from Water and Sewer Capital Improvement Plan Fund (2071) available unallocated prior sewer bonds.

AN ORDINANCE TO AMEND ORDINANCE NO. 857-X, THE 1997-98 BUDGET ORDINANCE, TO PROVIDE APPROPRIATIONS FOR A LOAN PROGRAM FOR JULY 1997 FLOOD VICTIMS.

Section 1. That the sum of \$1,000,000 is hereby available from the General Fund fund balance.


Section 2. That the sum of \$1,000,000 is hereby appropriated within the General Fund for business and residential loans to victims of the July 1997 floods.
