Section 1. That the sum of \$1,100,000 is estimated to be available from the Coliseum Authority and is hereby appropriated to the Municipal Debt Service Fund 5101.

Section 2. That the sum of \$6,500 is estimated to be available from a grant from the State's Governor's Highway Safety Program and is hereby appropriated to the General Fund 0101-Police Department. This grant may extend into future years. Therefore, this action is to remain in effect for the duration of the grant's authorization.

Section 3. That the sum of \$1,975 is estimated to be available from a grant from the State's Governor's Highway Safety Program and is hereby appropriated to the General Fund 0101-Police Department. This grant may extend into future years. Therefore, this action is to remain in effect for the duration of the grant's authorization.

Section 4. That the sum of \$31,828.63 is estimated to be available from grants from the State and is hereby appropriated to the General Fund 0101 for Emergency Management operations. These grants may extend into future years. Therefore, this action is to remain in effect for the duration of the grants' authorizations.

Section 5. That the sum of \$35,429 is estimated to be available from a Federal JTPA grant and is hereby appropriated to the Employment and Training Fund 6345 for job training programs. This grant may extend into future years. Therefore, this action is to remain in effect for the duration of the grant's authorization.

Section 6. That the additional sum of \$2,000 is estimated to be available from a Federal HOME grant and is hereby appropriated to the HOME Fund 6910. This grant may extend into future years. Therefore, this action is to remain in effect for the duration of the grant's authorization.

Section 7. That the additional sum of \$15,000 is estimated to be available from a Federal Fair Housing grant and is hereby appropriated to the Neighborhood Development Fund 6806. This grant may extend into future years. Therefore, this action is to remain in effect for the duration of the grant's authorization.

Section 8. That the sum of \$14,490 is estimated to be available from Federal (\$12,880) and

State (\$1,610) Transportation Planning grants and is hereby appropriated to the Transportation

Fund 7801. This grant may extend into future years. Therefore, this action is to remain in effect for the duration of the grant's authorization.

Section 9. That the sum of \$28,000 is estimated to be available from a State DOT grant (\$25,200) and local matching funds (\$2,800 from the Transportation Fund 7801 fund balance) and is hereby appropriated to the Transportation Fund 7801. This grant may extend into future years. Therefore, this action is to remain in effect for the duration of the grant's authorization.

Section 10. That the sum of \$425,000 is estimated to be available from a Federal (\$340,000) and State (\$42,500) Transportation grants and local matching funds (\$42,500 to be transferred from the Transportation Fund 7801 fund balance) and is hereby appropriated to the Transportation

Capital Improvement Fund 2078 for repairs to the Davidson Street Transit Center's roof. These grants may extend into future years. Therefore, this action is to remain in effect for the duration of the grants' authorization.

Section 11. That the Finance Director is hereby authorized to advance the sum of \$382,500 from the Transportation Fund 7801 fund balance until such time that the Federal and State grants in Section 10 above are received.
