AMENDING CHAPTER 13


AN ORDINANCE AMENDING CHAPTER 13 OF THE CITY CODE, ENTITLED "LICENSES", TO CONFORM THE CITY PRIVILEGE LICENSE TAX FOR PAWNBROKERS TO RECENT AMENDMENTS IN STATE LAW.

BE IT ORDAINED by the City Council of the City of Charlotte, N. C. that:

Section 1. Chapter 13, Section 51, classification No. (299) "PAWNBROKERS", of the Code of the City of Charlotte shall be amended by changing the tax from \$275.00 to \$100.00 to conform to recent legislative amendments to N.C.G.S. 105-88.

Section 2. This ordinance shall become effective upon adoption and will reflect the tax which is due for the current fiscal year beginning July 1, 1999 and ending June 30, 2000.

AN ORDINANCE TO AMEND ORDINANCE NUMBER 1313-X, THE 1999-2000 BUDGET ORDINANCE, ESTIMATING FEDERAL AND STATE GRANT REVENUES AND PROVIDING AN APPROPRIATION FOR THE PURCHASE OF 21 BUSES. THIS ORDINANCE ALSO ADVANCES FUNDING TO COVER ESTIMATED GRANT REVENUES FOR THE FY99 AND FY2000 TRANSIT ENTITLEMENT GRANTS.

BE IT ORDAINED, by the City Council of the City of Charlotte;

Section 1. That the sum of \$6,864,145 is hereby estimated to be available from the following sources of revenue:

Total	\$ 6,864,145


Section 2. That the sum of \$6,864,145 is hereby appropriated to Public Transportation Capital Project Fund 2078; 840.40 - FY2000 - 21 Buses.

Section 3. That the Finance Director is hereby authorized to advance the sums of \$5,879,248 to 2078;871.11 and \$6,180,625 to 2078; 840.40 from 2078; 814.00. That the advance is intended to cover the Federal and State Grants under this ordinance and Ordinance No. 1327-X. That the purpose of the advance is to provide funding at this time to facilitate timely purchase of buses and that the advance shall revert to its original source upon receipt of Federal and State Grant funding.

Section 4. All ordinances in conflict with this ordinance are hereby repealed.





AN ORDINANCE TO AMEND ORDINANCE NUMBER 1313-X, THE 1999-2000 BUDGET ORDINANCE, PROVIDING A SUPPLEMENTAL APPROPRIATION FOR CONSULTANT SERVICES AND BOND COUNSEL FOR THE CONVENTION CENTER HOTEL COMPLEX.

BE IT ORDAINED, by the City Council of the City of Charlotte;

- Section 1. That the sum of \$20,000 is hereby estimated to be available from a future convention center permanent financing.
- Section 2. That the sum of \$20,000 is hereby appropriated to the Convention Center Capital Project Fund 2013; 371.08 - Expansion-Hotel Complex.
- Section 3. That the Finance Director is hereby authorized to advance the sum of \$20,000 from the Convention Center Tax Fund (0132) fund balance to Fund 2013; 371.08 until such time that permanent financing is arranged. When permanent financing is arranged, this advance shall revert to the original source. If permanent financing is not arranged, the advance shall become the permanent source of funding.
- Section 4. All ordinances in conflict with this ordinance are hereby repealed.
- Section 5. This ordinance shall be effective immediately.




