Whereas, Donald W. Powers has filed a petition to close portions of an alleyway starting at Sunnyside Avenue and ending at an alleyway between Hawthorne and Lamar Avenues in the city of Charlotte; and

Whereas, portions of the alleyway starting at Sunnyside Avenue and ending at the alleyway between Hawthorne and Lamar Avenues to be closed lies north of Sunnyside Avenue and south of Central Avenue between Hawthorne and Lamar Avenues as shown in a map marked "Exhibit A" and is more particularly described by metes and bounds in a document marked "Exhibit B-, both of which are available for inspection in the office of the City Clerk, City Hall, Charlotte, North Carolina.

Whereas, the procedure for closing streets and alleys as outlined in North Carolina general statutes, Section 160A-299, requires that Council first adopt a resolution declaring it's intent to close the street and calling a public hearing on the question; said statute further requires that the resolution shall be published once a week for two successive weeks prior to the hearing, and a copy thereof be sent by registered or certified mail to all owners of property adjoining the street as shown on the county tax records, and a notice of the closing and public hearing shall be prominently posted in at least two places along said street or alley and

Now, therefore, be it resolved, by the city council of the city of Charlotte, at it's regularly scheduled session of January 25, 1999, that it intends to close portions of an alleyway starting at Sunnyside Avenue and ending at an alleyway between Hawthorne and Lamar Avenues, and that the said street (or portion thereof) being more particularly described on a map and by a metes ad bounds description available for inspection in the City Clerk's office, and hereby calls a public hearing on the question to be held at 7:00pm on Monday, the 22nd day of February, 1999 in CMGC meeting chamber, 600 East 4th Street Charlotte North Carolina.
