BE IT ORDAINED, by the City Council of the City of Charlotte;


Section 1. That the sum of \$200,000 is hereby estimated to be available from Street Bonds.



AN ORDINANCE TO AMEND ORDINANCE NUMBER 1313-X, THE 1999-2000 BUDGET  
ORDINANCE, PROVIDING AN APPROPRIATION FOR CARGO AREA SITE PREPARATION

BE IT ORDAINED, by the City Council of the City of Charlotte:

- Section 1. That the sum of \$1,185,855 is hereby estimated to be available from Airport Excluded Centers Fund (7404) to fund the sitework necessary for the construction of three aircraft parking positions and 100,000 square feet of cargo buildings
- Section 2. That the sum of 1,185,855 is hereby appropriated to the Airport Capital Project Fund 2073; Cost Center 56275.
- Section 3. That the existence of this program may extend beyond the end of the fiscal year. Therefore, this ordinance will remain in effect for the duration of the program and funds are to be carried forward to subsequent fiscal years until all funds are expended.
- Section 4. It is the intent of this ordinance to be effective upon its adoption.



**ZONING REGULATIONS**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:**

Section 1. That Section 1.104 of the City of Charlotte Zoning Ordinance is hereby amended by changing the property identified as approximately 3.3 acres located between South Church Street and Winnifred Street, north of West Bland Street (tax parcel 073-271-08) from General Industrial (I-2) to Mixed Use Development District (MUDD) on the Official Zoning Map, City of Charlotte, N.C.
