


Section 2. That the sum of \$9,492,715 is hereby appropriated to the Public Transit Capital Project Funds.

Upon receipt of grant assistance, the sources and levels of funding for the project specified in Section 1, above, may be adjusted to reflect permanent financing. Until permanent financing is achieved, the Finance Director is hereby authorized to advance funding from Fund 7801 fund balance to cover estimated grant revenues specified in Section 1, above. Upon receipt of grant revenues, funds advanced to the project shall revert back to the Fund 7801 fund balance. The total project appropriation level will not increase above that specified in Section 2, unless adjusted by subsequent ordinance.

Upon receipt of grant assistance, the sources and levels of funding for the project specified in Section 1 above may be adjusted to reflect permanent financing. Until permanent financing is secured, the Finance Director is hereby authorized to advance funding from Fund 7807 fund balance to cover estimated grant revenues specified in Section 1 above. Upon receipt of grant revenues, funds advanced to the project shall revert back to the Fund 7807 fund balance. The total project appropriation level will not increase above that specified in Section 2, unless indicated by subsequent ordinance.







Section 3. That this ordinance shall become effective upon its adoption.


