ORDINANCE NO. 1807-X

AN ORDINANCE TO IMPOSE A MONTHLY 911 CHARGE UPON EACH EXCHANGE ACCESS FACILITY IN THE AREA SERVICED BY THE CHARLOTTE-MECKLENBURG POLICE DEPARTMENT

WHEREAS, the City of Charlotte has in operation an Enhanced 911 System; and

WHEREAS, the General Assembly of North Carolina on July 5, 1989, amended Chapter 62A of the General Statutes of North Carolina ("Public Safety Telephone Act") to allow the governing authority of any local government to adopt an ordinance to impose a monthly 911 charge upon each exchange access facility subscribed to by all telephone subscribers whose exchange access lines are in the area served or which would be served by the 911 service; and

WHEREAS, the City Council for the City of Charlotte, North Carolina, after public notice, conducted a public hearing on May 14, 2001 on the question of imposing a monthly 911 charge and adopting an ordinance for the imposition of said monthly 911 charge as required by Section 62A-4(b)(2) of the North Carolina General Statutes.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE, NORTH CAROLINA, THAT:

Section 1. 911 Charges

The City of Charlotte hereby imposes a monthly charge in the initial amount of \$.73 upon each exchange access facility as defined by General Statute 62A-3(4), subscribed to by all telephone subscribers whose exchange access lines are in the area served or which would be served by Charlotte enhanced 911 service. The monthly charge shall be uniform and shall not vary according to the type of exchange access facility used.

Section 2. Adjustment to Monthly Charge

Prior to the beginning of each fiscal year and along with and at the same time as a public hearing conducted for the purpose of adopting the budget for the following fiscal year, the City Council for the City of Charlotte may adjust the amount of the monthly charge for the following fiscal year.

Section 3. Payment and Collection of Charges


Every service supplier, as defined by General Statutes 62A-3(8), providing 911 service, shall collect the charges as part of its normal monthly billing process from those subscribers to whom it provides exchange telephone service in the area served by the 911 service, pursuant to the provisions of General Statute 62A-5. The service supplier shall

remit the charges it collects, less a one percent (1%) administrative fee, to the fiscal officer of the City who shall allocate the funds to the appropriate City and County agencies providing 911 service.

Section 4. Effective Date

This ordinance and the collection of charges as provided in the ordinance shall become effective 120 days after adoption of the ordinance.


