
That the sum of \$2,500,000 is hereby appropriated to Fund 2098; 894.70.

Section 3. This ordinance estimates Federal and State grant participation in the projects. Upon receipt of grant assistance, the sources and levels of funding for the projects specified in Sections 1 and 2, above, may be adjusted to reflect permanent financing. Until permanent financing is achieved, the Finance Director is hereby authorized to advance funding from Fund 7801 fund balance to cover estimated grant revenues specified in Sections 1 and 2, above. Upon receipt of grant revenues, funds advanced to the projects shall revert back to the Fund 7801 fund balance. 





ORDINANCE NUMBER: 2343

AMENDING CHAPTER 14

**ORDINANCE AMENDING CHAPTER 14 OF THE CHARLOTTE CITY CODE
ENTITLED MOTOR VEHICLES AND TRAFFIC**

Section 1. Chapter 14 of the Charlotte City Code is amended by rewriting Sec. 14-228 to read as follows:

Sec. 14-228. Offense.

(a) It shall be unlawful for a vehicle to cross the stop line at a system location when the traffic signal for that vehicle's direction of travel is emitting a steady red light, or for a vehicle to violate any other traffic regulation specified in G.S. 20-158.

(b) The owner of a vehicle shall be responsible for a violation unless the owner can furnish evidence that the vehicle was, at the time of the violation, in the care, custody, or control of another person. The owner of the vehicle shall not be responsible for the violation if the owner of the vehicle, within 30 days after notification of the violation, furnishes the officials or agents of the city either of the following:

- (1) An affidavit stating the name and address of the person or company who had the care, custody, and control of the vehicle; or
- (2) An affidavit stating that the vehicle involved was, at the time, stolen. The affidavit must be supported with evidence that supports the affidavit, including insurance or police report information.

(c) Subdivision (b) of this subsection shall not apply, and the registered owner of the vehicle shall not be responsible for the violation, if notification of the violation is given to the registered owner of the vehicle more than 90 days after the date of the violation.

(d) For purpose of this Article, "notification of the violation" shall be deemed to have to have been given on the date that the citation is issued.

Section 2. Chapter 14 of the Charlotte City Code is amended by rewriting Sec. 14-229 to read as follows:

Sec. 14-229. Penalty.

A violation detected by a traffic control photographic system shall be deemed a noncriminal violation for which a civil penalty of fifty dollars (\$50.00) shall be assessed, and for which no points authorized by G.S. 20-16(c) shall be assigned to the owner or driver of the vehicle nor insurance points as authorized by G.S. 58-36-65. The owner of the vehicle shall be issued a citation which shall clearly state the manner in which the violation may be challenged, and the owner shall comply with the directions on the citation. The citation shall be processed by officials or agents of the city and shall be

forwarded by personal service or first-class mail to the address given on the motor vehicle registration. If the owner fails, within thirty days of notification of the violation, to pay the civil penalty, appeal the citation, or respond in accordance with Sec. 14-228(b), the owner shall have waived the right to contest responsibility for the violation, and shall be assessed an additional civil penalty of fifty dollars (\$50.00). The city may establish procedures for the collection of these penalties and may enforce the penalties by civil action in the nature of debt.


Section 3. Chapter 14 of the Charlotte City Code is amended by rewriting Sec. 14-230 to read as follows:

Sec. 14-230. Appeals.

A notice of appeal may be filed within thirty days after notification of the violation and must be accompanied by an appeal bond in an amount equal to the civil penalty. Appeals shall be heard through an administrative process established by the City of Charlotte Department of Transportation, which process shall include the right to a quasi-judicial hearing. The hearing officer's decision is subject to review in the Superior Court of Mecklenburg County by proceedings in the nature of certiorari, which proceeding must be initiated within thirty days of issuance of the hearing officer's written decision.

Section 4. This ordinance shall become effective upon 2003 General Assembly House Bill 786 becoming law.




ORDINANCE AMENDING CHAPTER 16 THE CHARLOTTE CITY CODE
ENTITLED "CITIZENS REVIEW BOARD."

Section 1. Sec. 16-35. Meetings is rewritten to read as follows:

The Citizens Review Board shall hold regular meetings as scheduled by resolution of the Board. The affirmative vote of a majority, a quorum being present, shall be required before any recommendation is made on any matter considered. A majority vote shall be required for any decision made by the board. Special meetings may be called by the chairperson to carry out duties described in Section 16-36 by giving members notice in writing or by providing personal notice, or leaving notice at the member's residence not less than seventy-two (72) hours prior to the time set for the meeting.

Section 2. This ordinance shall become effective upon adoption.


