

AN ORDINANCE TO AMEND ORDINANCE NUMBER 2620-X, THE 2004-2005 BUDGET ORDINANCE PROVIDING A SUPPLEMENTAL APPROPRIATION FOR THE LONG CREEK PARALLEL OUTFALL PROJECT

BE IT ORDAINED, by the City Council of the City of Charlotte;

- Section 1. That the sum of \$8,300,000 is hereby estimated to be available from Water and Sewer Revenue Bonds.
- Section 2. That the sum of \$8,300,000 is hereby appropriated to Long Creek Parallel Outfall projects in the Water and Sewer Capital Project Fund (2071) as follows:
- \$3,000,000 to 632.12 Long Creek Parallel Outfall Phase I
 - \$5,300,000 to 633.73 Long Creek Parallel Outfall Phase II
- Section 3. That the existence of this project may extend beyond the end of the fiscal year. Therefore, this ordinance will remain in effect for the duration of the project and funds are to be carried forward to subsequent fiscal years until all funds are expended or the project is officially closed.
- Section 3. All ordinances in conflict with this ordinance are hereby repealed.
- Section 4. This ordinance shall be effective upon adoption.
