

- Section 3. All ordinances in conflict with this ordinance are hereby repealed.
- Section 4. This ordinance shall be effective upon adoption.



AN ORDINANCE TO AMEND ORDINANCE NUMBER 2996-X, THE 2005-2006 BUDGET ORDINANCE, PROVIDING AN APPROPRIATION FROM US DEPARTMENT OF JUSTICE AND FROM POLICE ASSETS FORFEITURE FUNDS FOR DNA ANALYST SALARY

AN ORDINANCE TO AMEND ORDINANCE NUMBER 2996-X, THE 2005-2006 BUDGET ORDINANCE, APPROPRIATING AIRPORT DISCRETIONARY FUNDS FOR REMOVAL AND REPLACEMENT OF EXISTING ROOF ON CONCOURSE B.

BE IT ORDAINED; by the City Council of the City of Charlotte;

Section 1. That the sum of \$700,000 is available from Airport Discretionary Funds. These funds will be repaid from the proceeds of future General Airport Revenue Bonds.


Section 2. That the sum of \$700,000 is hereby appropriated to the Aviation Capital Projects Fund (2090-540.09).

Section 3. That the existence of the project may extend beyond the end of the fiscal year. Therefore, this ordinance will remain in effect for the duration of the program and funds are to be carried forward to subsequent fiscal years until all funds are expended.

Section 4. All ordinances in conflict with this ordinance are hereby repealed.

Section 5. This ordinance shall be effective upon adoption.
