



- Section 4. This ordinance shall be effective immediately.



AN ORDINANCE TO AMEND ORDINANCE NUMBER 2996-X, THE 2005-2006 BUDGET ORDINANCE, ESTIMATING FUTURE DEBT FINANCING AND FEDERAL GRANT REVENUES AND PROVIDING FUNDING APPROPRIATIONS AND FUNDING ADVANCES FOR CONVENTION CENTER MODIFICATIONS - PHASE II.

BE IT ORDAINED, by the City Council of the City of Charlotte;

- Section 1. That the sum of \$5,550,000 is hereby estimated to be available from future Certificates of Participation (COPs) and is hereby appropriated to Convention Center Capital Projects Fund 2013; 239.01 - Convention Center/Trolley.
- Section 2. That the Finance Director is hereby authorized to advance the sum of \$5,550,000 from the Convention Center Tax Fund (0132) fund balance to the project in Section 1, above, until such time that COPs financing is arranged. If COPs financing is not arranged, the advance from Fund 0132 fund balance becomes the permanent source of funding for the project. If permanent financing is arranged, the advance shall revert to the original source of funding.
- Section 3. That the sum of \$385,200 is hereby available from the CATS Operating Fund (7801) fund balance and is hereby appropriated to Rapid Transit Capital Projects Fund 2098; 536.80.
- Section 4. That the sum of \$8,914,800 is hereby estimated to be available from Federal grants and is hereby appropriated to Rapid Transit Capital Projects Fund 2098; 896.00.
- Section 5. That the Finance Director is hereby authorized to advance the sum of \$8,914,800 from the CATS Operating Fund (7801) fund balance to the project in Section 4, above, until such time that Federal grants are realized. If Federal grants are not realized, the advance from Fund 7801 fund balance becomes the permanent source of funding for the project. If Federal grants are realized, the advance shall revert to the original source of funding.
- Section 6. All ordinances in conflict with this ordinance are hereby repealed.
- Section 7. This ordinance shall be effective immediately.
