

- Section 4. This ordinance shall be effective immediately.



Section 1. That the sum of \$270,000 is hereby estimated to be available from the North Carolina Department of Health and human services, Office of Emergency Medical Services


Section 2. That the sum of \$270,000 is hereby appropriated to the Public Safety Grants Fund (0413) Center 402.50






